# PROJECT DESCRIPTION

This project provides for the County's contribution to the City of Takoma Park for the construction of the sidewalk and the rehabilitation of Flower Avenue (MD 787) between Piney Branch Road and Carroll Avenue. The City of Takoma Park will annex the full width of the right-of-way on the east side of the road and take ownership and maintenance responsibilities from the State. The City will transform the road into a green street, including the construction of an ADA compliant sidewalk on the east side of the road. The County's contribution is subject to the County's review and concurrence of the scope of work for the sidewalk component of the green street project.

## **LOCATION**

Flower Avenue between Piney Branch Road and Carroll Avenue

## PROJECT JUSTIFICATION

Flower Avenue is heavily traveled by transit riders and pedestrians. Washington Adventist University and Washington Adventist

Hospital are on this stretch of Flower Avenue. Various Ride On routes serve this segment. Rolling Terrace Elementary School, the Long Branch commercial district, library and recreation center, and the future Long Branch Purple Line stop are all within a few blocks. The project would convert a mile-long street into a green street.

### **OTHER**

Expenditures will be programmed in FY18. The City of Takoma Park is expected to accept transfer of the road and build the green street and sidewalk in advance of the County's contribution. This project also supports the County Executive's Vision Zero initiative which aims to reduce injuries and fatalities on all roads.


## FISCAL NOTE
