REQUEST FOR WAIVER OF ACCESSORY APARTMENT PARKING REQUIREMENTS**

NOTICE OF HEARING

Please take notice that the Office of Zoning and Administrative Hearings for Montgomery County, Maryland (OZAH), will hold a public hearing in the Stella B. Werner Council Office Building, Second Floor Davidson Memorial Hearing Room, at 100 Maryland Avenue, Rockville, Maryland, on **Friday, April 26, 2019, at 9:30 a.m.** or as soon thereafter as this matter can be heard, on the above-captioned Request for a Waiver of the Accessory Apartment Parking Requirements of Zoning Ordinance §59.3.3.3.A.2.c.ii(a).

The Waiver Request was filed with OZAH on April 16, 2019, regarding the Requester's Application No. 109895 to the Department of Housing and Community Affairs (DHCA) for an *Attached Accessory Apartment* license, which application was filed with DHCA on January 25, 2019. On March 8, 2019, DHCA referred the matter to OZAH due to the inadequacy of on-site parking. These procedures are governed by County Code §§29-16, 29-19, 29-26, 59.333. A & B, and OZAH's Rules of Procedure for Agency Referral and Accessory Apartment Cases.

The subject property is Lot 51, Block M, of the Clarksburg Village Subdivision, located at 12549 Blue Sky Drive, Clarksburg, Maryland 20871, in the R-20 Zone (Tax Account Number 02-03521645).

The entire file may be reviewed in the Office of Zoning and Administrative Hearings, Monday through Friday, between the hours of 9:00 a.m. and 4:00 p.m., prior to the date of the hearing.

Any parties represented by counsel must submit electronic copies of their supporting documents prior to the hearing. Electronic copies must be submitted on compact discs, in Microsoft WORD format for text documents, and in PDF format for plans and other non-text documents.
