Dear Mr. Pajot:

First, I agreed to keep the record open for an updated landscape plan, not forest conservation plan. The Hearing Examiner does not adjudicate the forest conservation plan. Further, I did not limit the parameters under which the record will be kept open. That would have been premature, as the hearing had not concluded.

Regardless, after the opposition presents, the applicant still has the option to present a rebuttal case during which the applicant may introduce additional exhibits to counter the opposition case.

Simply because an exhibit has been posted to the OZAH website does not mean that it has been admitted into evidence. OZAH uploads proposed exhibits in advance as a courtesy so that the public can anticipate the content of the hearing.

The onus remains on the party introducing an exhibit to formally request at the time of introduction or at the conclusion of the hearing that proposed exhibit be admitted into evidence and the Hearing Examiner then makes a determination whether to admit the exhibit.

I hope this clarifies. I will do my best to answer process questions tomorrow.
