I apologize for the delay in getting back to you on this.

Distances in the Zoning Ordinance are measured in a straight line ("as a crow flies") from one property line to the other property line.

In this case I actually measured in a straight line from a few feet inside the Property for this application and measured to the entrance to the tunnel where a person would walk into the station from the outside. If you measure to the actual Metro property line, it measures to 1.72 miles.
