1. Welcome / Announcements

Wendy Stickle, PhD, Chair (10 min)

2. Update: Police Accountability Board (PAB) and Administrative Charging Committee (ACC)

Summary: Earl provided the group with a status update as to where we are with getting the PAB/ACC stood up including the complaint portal and where MPTSC is with Training/Matrix etc.

3. Briefing: Legislative Review

Senator William C. Smith Jr., District 20, Silver Spring / Takoma Park (30 min)

Summary: Sen. Smith shared an overview of key legislation that pertained to Parole, Juvenile Justice, Police Reform, Ghost Guns and took questions from the group. Sen. - •Chief Jones shared with the group the Call to Action regarding increase in Juvenile Violence and the need for the Community to get involved. - Kurt van der Walde suggested we look at this model to prevent domestic violence homicides: https://jeannegeigercrisiscenter.org/domestic-violence-homicide-prevention/
- •Dr. Crowel and Sheriff Popkin discussed <u>Maryland's Extreme Risk Protective Orders</u> and how we should educate our Healthcare professionals and Students regarding what they can do to prevent 'persons who poses an immediate and present danger from causing personal injury to self or others by having firearms'
- Chief Brito raised concern over police in schools. Richard Madaleno suggested review of the <u>FY23 budget</u> specific in the MCPS portion of the budget where it calls out staffing of 275 security staff, 619 Counselors, 147 psychologists, 90 Social Workers and 105 Pupil Personnel workers.
