Specifically, whether we should

- 1. Have a webpage, share information about agenda/reports
- 2. Public Notices: Lisa is responsible for this.
- 3. Motions & Parliamentary procedures, may be good to use on major recommendation to demonstrate consensus.
- II. Child Welfare Report (See last month's report on next page for reference)
 - Do you use the numbers to model anything? Yes, we do, we are looking at those to help manage case loads, because we have so many vacancies.
 - How does MCCRP use these numbers:
 - Helps inform us what we want to study, or helps us to monitor what how things are going.
 - Foster Parent Forum today, and discussion with how the department can support them.
 - Substance counselors who did assessments, made referrals, no longer funded.
 START has been delayed.
 - Family First Act regional meetings to be held in the next few weeks.
 - Still need a Spanish speaker recruiter.
 - Spent the whole year talking about Substance Abuse need and value, and it just stopped. Do we need to do something.
 - Has Lisa found funding to cover the team that was here.

- Our concern about START was that it was specific and a certain population.
- State money (no county money), so who do we call? Delay due to position definition/
- Follow Up, we'd like more information about what happens with START, and how the money dried up for the previous program.
- HHS Committee -
 - Ask for a meeting to talk about the non-start of START
 - START program is on hold
 - Youth transitioning out of care
 - Monitoring implementation of CJAMS
- III. Discussion and Decision about issues to pursue for 2019/2020 (Breaking into Committees). Topic ideas:
 - 1. Transition and mentoring
 - 2. Operations of child welfare agency (right data, Start, recruitment/child care payment, committees, staffing/retention)
 - 3. Prevention and Substance Abuse (Mental Health and suicide)

Question: What's the process for selecting what we work on? How do we decide, and what is the impact of what we do?

In the past, worked with agency to pick topics to help them with their work. We'd pick one, come up with a plan, and support the agency. Surveys, reports, etc.
