## **Agency Update**

Ms. Merkin reviewed the agency's data for September 2023.

As anticipated, there has been an increase in referrals and reports of abuse as school is back in session.

Out of home placements remained stable even with the increase in referrals. Referrals do take time to investigate. Additionally, the provision of in-home services reduces can address the issues that resulted in the referral.

There was an increase in the number of inquiries to be resource homes. The agency is looking into whether the increase can be attributed to recent outreach efforts, including information featured on the MoCo Show.

## Recap of Quarterly Boards, Commissions and Committees Meeting

The Director of the Montgomery County Department of Health and Human Services holds quarterly leadership meetings with the Boards, Commissions and Committees (BCC) to receive reports on activities completed, activities anticipated, collaboration with other Boards, Commissions and Committees.

Ms. Mc Neely reviewed the MCCRP activity report submitted for the September 20, 2023 leadership meeting. The report focused on three activities -1) monthly review and analysis of data, 2) efforts to assist the agency with recruitment of resource homes, and 3) efforts to assist the agency with retention of resource homes.

- Resource Home Recruitment targeting untapped communities and strategies for emergency placement homes, and
- Resource Home Retention helping resource families to deal with grief and loss at the time of reunification.

Ms. McNeely and Ms. Merkin will be presenting the MCCRP's priorities to the Committee on the 12<sup>th</sup>.

# Resource Home Recruitment and Retention Sub-Panels

The subpanel will be meeting soon to discuss next steps.

Targeting Untapped Communities and Strategies for Emergency Placement Homes Subpanel

The subpanel divided up the agency-approved list of personal connections and other groups to target for outreach. A draft email has been submitted to the agency for edits and approval. Once approved, the email will be used by subpanel members for outreach.
