Ms. McNeely advised that Shaoli Katana is currently not able to attend the MCCRP meetings.

Review and Approval of the Minutes

The draft minutes of the December 12, 2023 meeting were distributed prior to the meeting. Ms. Tinuade Akinshola pointed out two needed corrections in the draft minutes and then made the motion to approve the revised minutes. Ms. Laura Coyle seconded the motion. The revised minutes were approved.

Agency Update

Ms. Lisa Merkin reviewed the agency's data for December 2023.

As anticipated, there has been an increase in referrals and reports of abuse due to school referrals. Out-of-home placements continued to be stable even with the increase in referrals. Out-of-home placements can be avoided with the provision of in-home services.

Ms. Merkin advised that there was nothing unexpected in the data. Decreases were expected as there are fewer court dates over the holidays. The increase in out of home placements related to a sibling group.

Ms. Merkin also reported that the agency is in the final stages of developing a videotape to help in the recruitment of resource homes. There will be two versions of the videotape – commercial/ad length version and a longer version that can be used in presentations. The agency involved three resource families in the development of the videotape and hope to have the videotape finished within the next couple of weeks. The videotape will be placed on the agency and county websites as soon as finished. The agency is working on a plan for further distribution, which will be impacted by available funding. Ms. Coyle asked if a Spanish version of the videotape will be available. Ms. Merkin will check and report back.

Resource Home Recruitment and Retention Sub-Panels

Helping Resource Families to Deal with Grief and Loss at Reunification Subpanel

Ms. Coyle reported for the subpanel. The spreadsheet of potential resources is close to finalization.

Targeting Untapped Communities and Strategies for Emergency Placement Homes Subpanel

Subpanel members are reaching out to the groups identified. For example, Ms. Akinshola shared the recruitment letter with her pastor and is awaiting a response.

At a previous meeting, a question was asked about the possibility of putting the approved correspondence language on agency or county letterhead. Ms. Merkin advised that the subpanel members could not use letterhead.

Other Business

A question was asked about planning for the 2024 Spring Forum. Ms. Merkin advised that she had not heard anything yet. She will reach out to the Diane Lininger of the Mental Health Advisory Committee to check on the status of the planning.

Ms. McNeely advised that Montgomery County is updating the Community Connect portal, which can be used by the public to access information and services. The County is looking for volunteers to test the update. Ms. McNeely will share with the MCCRP members the correspondence she received that provides information on volunteering to help with the testing.
