**I. CALL TO ORDER**

**II. PRESENTATION: Legislative Update from MASSB**

- Marquette reviewed key Maryland state legislation being tracked by MASSB. Due to COVID there are significantly fewer bills being considered by the legislature and tracked by MASSB as relevant to the Boards’ mission. These include: Family Law provisions on investigating suspected child sexual abuse, mandatory reporting training, child custody and visitation; Higher Education tuition exemption for foster care and homeless youth; Public Safety youth violence review, civil actions, child abuse; Electric and gas energy suppliers; Human Services SNAP “heat and eat” program; COVID relief; Mental health resources and treatment capacity, hospital overstay for youth; Foster parents right to intervene.
- Marquette will send the MASSB slides to the Board. Oscar Mensah will send a link to the Maryland legislative website for those Board members who want to track specific legislation.
- Update Montgomery County’s handbook based on the MASSB handbook on items such as: review process, structure, fundraising, attendance, priorities.

**III. NEW BUSINESS**

**a. Future discussions and topics**

- April is Child Abuse Prevention month. Perhaps plan activities in March to prep and April to begin re: children coping with COVID; mental health/resilience activities; understanding what is being done and gaps.
- Samaura volunteered to pull together some research on what the county, schools, other boards, etc. are doing on this topic, so we can plan activities for June/July

**b. Reappointments and new applications**

- Oscar reported that 6 new members to our board are likely to be officially appointed in the next month or so, 2 members will be reappointed. He is working on an orientation packet and time for the new members.
