I. CALL TO ORDER

- The meeting was called to order at 4:09 pm.
- A motion was made to accept the March 7, 2022 meeting notes by Kendell Battle and seconded by Brandon Bragg.

II. NEW BUSINESS

• HHS Staff Hannah Shaw updated the <u>Board Member Handbook for 2021-2022</u>. The Chair <u>highlighted sections on Officers and Attendance</u>.

Re "Officers," a discussion centered on annual election of the Board Chair.

<u>Action item #1</u>: Keep language "must elect" a Board Chair annually, but consider language for exceptions to an annual vote (*e.g.* in light of virtual meetings).

<u>Re</u>: "Attendance," a discussion centered on meetings and permitted absences. With nine (9) BSS meetings, members are permitted three (3) absences, noting that a Board Member is subject to dismissal with three (3) consecutive absences.

The Chair also raised the issue of "Subcommittees" and noted that subcommittees may include non Board Members and that the Board's four (4) existing Subcommittees can help to spread the work.

<u>Action item #2</u>: HHS Staff Oscar Mensah reported that the BSS will receive a Summary of Legislation passed by the Maryland Legislature and the Legislative SubCommittee Chair will review.

• Partnership with Montgomery County Citizen Review Panel for Children ("Panel")

Marcy Frosh reported on discussion with Panel Chair Marci McCoy and potential to
collaborate to support transitioning foster youth with internship information and to formulate a
survey to the youth on their most pressing needs in general.

Action item #1: Board expressed support for outreach to the Bethesda-Chevy Chase High School internship program and potential for their leadership to provide information on sponsors and procedures to the BSS at a Board Meeting. Marcy Frosh will follow up with Marci McCoy.

<u>Action Item #2</u> – Chair to share information with the Board about a MASSB Call for all social services boards on April 22 focused on Foster Youth.

<u>Action Item #3</u> - Support expressed by the Vice Chair and the Board to work with Marci McCoy on a needs survey of transitioning foster youth. Marcy Frosh will follow up and share information with the Vice Chair and the Outreach and Communications Subcommittee for further action.
