Consent Agenda Applications:

1. Clearwire application to attach four 3' panel antennas, and four 2' dish antennas at the 90' level on a 100' monopole at Wheaton High School located at 12501 Dalewood Drive in Silver Spring (Application #200611-14).
2. FiberTower application to attach one 2' dish antenna and two 14" dish antennas to the penthouse wall at the 141' level atop the 125' Claridge House apartment building located at 2445 Lyttonsville Road in Silver Spring (Application #200704-07).
3. FiberTower application to attach two 14" dish antennas to the penthouse wall at the 113' and 114' level atop the 100' Summit Hills apartment building located at 8484 16th Street in Silver Spring (Application #200704-08).
