

CODE ENFORCEMENT

During the month of November 2011, the Code Enforcement team litigated 326 cases in Montgomery County District Court, resulting in judgments totaling \$33,300.00. The team received 205 new citations during this month, as itemized below with the amount of fines sought by those citations. A total of \$182,749.55 was collected in fines from outstanding cases for FY12. The County closed 161 outstanding cases after collecting fines and/or having violations abated, or referring cases to the Debt Collection Unit, during this month.
