### Smart Benefits - Frequently Asked Questions



Commuter Services is available to assist you with SmartBenefits, a web-based program that lets employers assign the dollar amount of employees' monthly commuting benefit directly to employees' SmarTrip cards. In each issue we will highlight your questions

and answer them.

**Question:** Can I still use my Metrocheks as Metrorail farecards?

**Answer:** Yes, you can use Metrocheks as farecards but as of April 1, 2009 you can no longer exchange them for other rail or bus passes.

**Question:** Where can I buy MARC rail tickets? **Answer:** You can only buy tickets at Union Station (DC), and stations in Frederick and Brunswick. Or, you can purchase tickets through **Commuter Direct**. For more information, call 240-773-8747 (*TRIPS*).

## Commuter Stores - *New Name, New Locations*



**TRIPS** stands for Transportation Resources, Information and Places to See, a fitting name for a commuter store that provides fare media (i.e., bus passes and tokens, Metrorail farecards, and SmarTrip cards) and visitor information). Existing transit system riders, new riders and visitors can get personalized assistance when purchasing fare media or making connections to regional transportation. Transit-related merchandise is also available.

## File Traffic Mitigation Plans and Annual Reports Online

Now it's even easier for businesses to comply with traffic mitigation requirements for employers in Montgomery County. Employers with 25 or more employees located in a Transportation Management District (TMD) are required by law to file a Traffic Mitigation Plan (TMP) and Annual Report.
