### WHO SHOULD BUY A POOL PASS?

The admission fees listed above are the primary forms of entry for Rec Swim Periods. Patrons who intend to use the pools regularly are urged to consider purchasing an individual or family pool pass in order to save money and simplify admission at the front desk. Some may find that an individual pass is suitable for the more frequent swimmer in a family, but the admission fee or the "P12 Card" is the most economical for the infrequent swimmer.

### NOTES CONCERNING OUTDOOR POOL PASSES

- Glenmont Outdoor Pool passes will be honored at any MCRD operated outdoor pool. OUTDOOR POOL PASSES ARE NOT VALID AT COUNTY-OPERATED INDOOR POOLS.
- Passes are non-transferable and non-refundable.
- Passes/finger scans will be issued to individual family members. Swim passes are through County ACCESS Cards, new cards are not issued with renewals. Finger Scanning will be in place at all outdoor pools.
- The Recreation Department is not responsible for the loss of theft of personal property.
- LOCK POSSESSIONS IN A LOCKER. LEAVE VALUABLES AT HOME.
- You must scan your pass/finger for ALL ENTRIES into the Center. If you do not have a pass to scan, you WILL BE CHARGED admission or required to have your finger scanned. NO EXCEPTIONS.
- All passes expire Labor Day, September 5<sup>th</sup>. During seasons when school starts before Labor Day, some outdoor pools will be closed, while others will have limited schedules through Labor Day.
