<b>ADMISSION FEES FOR NON-PASSHOLDERS (PER EACH ENTRY)</b>		
	County Resident	Non-County Resident
<b>Minor</b> (age 1-17 years) .....	\$4.00	\$6.50
<b>Adult</b> (age 18 and older) .....	\$6.00	\$7.50
<b>Senior</b> (age 55 and over, with I.D.) .....	\$4.50	\$6.50
A driver's license or other proof of residency is required at the admission counter. Patrons must pay the admission or present a pool pass upon each entry.		
<b>"P12 CARDS", good for 12 entries for the price of 10, are on sale at each pool. "P12 Cards" are like cash, non-refundable. See Cashier for details.</b>		

### WHO SHOULD BUY A POOL PASS?

The admission fees listed above are the primary forms of entry for Rec Swim Periods. Patrons who intend to use the pools regularly are urged to consider purchasing an individual or family pool pass in order to save money and simplify admission at the front desk. Some may find that an individual pass is suitable for the more frequent swimmer in a family, but the admission fee or the "P12 Card" is the most economical for the infrequent swimmer.

### NOTES CONCERNING ANNUAL POOL PASSES

- GISC passes will be honored at any MCRD operated indoor or outdoor pool.
- **Passes are non-transferable and non-refundable.**
- Passes will be issued to individual family members. Swim passes are now issued through County ACCESS Cards, new cards are not issued with renewals. There will be a charge of \$5.00 for replacement of a lost ACCESS CARD.
- The Recreation Department is not responsible for the loss of theft of personal property.
- LOCK POSSESSIONS IN A LOCKER. LEAVE VALUABLES AT HOME.
- **You must scan your finger over the Biometric Scanner or ACCESS CARD for ALL ENTRIES into the Center. If you do not, you WILL BE CHARGED admission. NO EXCEPTIONS.**
- All passes expire September 1<sup>st</sup>.
