- Created -- Montgomery County Code Section 31C-4
- Purpose -- To certify to the Executive Director of the Office of Consumer Affairs whether the applicant and the organization of the applicant are qualified to comply with the building code and laws of the County and State and to fully perform building contracts and that the applicant should be licensed.
- Membership -- Five members - no more than two members must be active in the residential construction field at the time of their appointment.
- Financial Disclosure -- Confidential disclosure required.
- Terms -- Three year terms - no compensation
- Meetings -- First Tuesday of each month at 8:30 a.m.



County Executive Isiah Leggett is seeking applicants to fill two vacancies, one builder member (active in the residential construction field) and one public member, on the Board of Registration for Building Contractors. The public member is eligible to apply for reappointment.

The five-member Board is composed of builder and public representatives who provide for the licensing of residential building contractors. The Board holds hearings and can revoke, suspend or deny licenses. Members serve three-year terms without compensation, but are eligible for reimbursement for travel and dependent care for meetings attended. Meetings are held the first Tuesday morning of each month at **8:30 AM** in Rockville. **Members are required to file a confidential financial disclosure statement within 15 days of Council confirmation and each annual period thereafter.**

Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply. An application, consisting of a **brief cover letter and resume**, should be sent by mail to County Executive Isiah Leggett, 101 Monroe Street, 2nd Floor, Rockville, MD 20850, or by email to [countyexecutive.boards@montgomerycountymd.gov](mailto:countyexecutive.boards@montgomerycountymd.gov). Home and employment addresses, as well as contact phone numbers and email addresses should be included. If appropriate, applicants should indicate the position for which they are applying. The deadline for application is **December 10, 2014**.

Members of County boards, committees and commissions may not serve on more than one such group at a time. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
