	<u>REMOVE:</u> (T.O. 587) One Way	<u>In Silver Spring:</u> On Kimball Place from Gardiner Avenue to McMillan Avenue so as to make Kimball Place one-way in a easterly direction.
	<u>REMOVE:</u> (T.O. 587) No Parking Any Time	<u>In Silver Spring:</u> On the south side of Kimball Place from Caney Place to a point 105' westward.
	<u>REMOVE:</u> (T.O. 587) No Parking Any Time	<u>In Silver Spring:</u> On the north side of Kimball Place from Gardiner Avenue to McMillan Avenue.
	<u>REMOVE:</u> (T.O. 587) Stop	<u>In Silver Spring:</u> On McMillan Avenue at Holman Avenue so as to stop north and southbound traffic on McMillan Avenue.
	<u>REMOVE:</u> (T.O. 587) One Way	<u>In Silver Spring:</u> On McMillan Avenue from Kimball Place to Holman Avenue so as to make McMillan Avenue one-way in a northwesterly direction.
	<u>REMOVE:</u> (T.O. 587) No Parking Any Time	<u>In Silver Spring:</u> On both sides of McMillan Avenue from Kimball Place to Holman Avenue.
1a	<u>INSTALL:</u> Stop	<u>In Silver Spring:</u> for northbound and southbound traffic on McMillan Avenue at Holman Avenue.
2a	<u>INSTALL:</u> No Parking Any Time	<u>In Silver Spring:</u> on the north side of Kimball Place from Gardiner Avenue to McMillan Avenue.
3a	<u>INSTALL:</u> No Parking Any Time	<u>In Silver Spring:</u> on the north side of McMillan Avenue from Kimball Place to Holman Avenue.
