WHEREAS, pursuant to Section 31-48, Montgomery County Code 2014, as amended, and COMCOR §§31.48.01.01, *et seq.*, a public hearing was held on Wednesday, February 28, 2018, to consider the creation of multiple new Residential Permit Parking Areas (the "RPPAs") in Silver Spring.

WHEREAS, twelve (12) new RPPAs were proposed in Silver Spring encompassing those neighborhoods within an approximate 4,000 foot radius of future Purple Line light rail stations (the "Metro Impact Areas").

WHEREAS, the Hearing Examiner concluded that criteria established in 31-48 of the Montgomery County Code has been satisfied to establish the RPPAs to address non-local parking.

WHEREAS, the Hearing Examiner recommends the advance establishment of RPPAs to prevent the occurrence of a spillover parking problem and to allow expeditious response to a problem should one develop within the Purple Line Metro Impact Areas.

WHEREAS, I concur with the conclusions and recommendations of the Hearing Examiner.

THEREFORE, I designate the following Purple Line Metro-Impact RPPAs:

RPPA:

Boundaries:

(1.) Park Hills

Bounded on the north by the south side of Wayne Avenue (MD 594A) from Dale Drive east to Sligo Creek Parkway; on the east by the west side of Sligo Creek Parkway from Wayne Avenue (MD 594A) to Dale Drive; on the south and west by the north side of Dale Drive from Galveston Road to Wayne Avenue (MD 594A).

(2.) Sligo Creek

Bounded on the north by the northern property line of 9039 Sligo Creek Parkway; on the east by Manchester Road from the road terminus north of Croydon Court to East Wayne Avenue (MD 594A); on the south by the north side of Piney Branch Road (MD 320) from Manchester Road to Sligo Creek Parkway; and on the west by the east side of Sligo Creek Parkway from Piney Branch Road (MD 320) to Three Oaks Drive.

- (3.) Highland View West Bounded on the north by the south side of Franklin Avenue from Leighton Avenue to Flower Avenue; on east by the west side of Flower Avenue from Franklin Avenue to East Wayne Avenue; on the south by the north side of East Wayne Avenue (MD 594A) from Flower Avenue to Eton Road; and on the west by Eton Road from East Wayne Avenue (MD 594A) to Oldham Road (segment one), on Providence Avenue from Oldham Road to Melbourne Avenue (segment two), on the east side of Leighton Avenue from Caroline Avenue to Franklin Avenue (segment three).
- (4.) Highland View East Bounded on the north by the south side of East Franklin Avenue from Flower Avenue to Evergreen Street; on the east by Mintwood Street from the road terminus north of East Hamilton Avenue to East Hamilton Avenue, Wilmer Street from Mintwood Street to Wendell Street, Wendell Street from Wilmer Street to East Schuyler Road, the north side of East Schuyler Road from Wendell Street to Walden Road, Walden Road from East Schuyler Road to East Wayne Avenue, the south side of East Wayne Avenue from Walden Road to Garland Avenue, Garland Avenue from East Wayne Avenue to the road terminus south of Hinsdale Lane; on the south by Hinsdale Lane from Garland Avenue to Whitney Street (segment one), and the north side of Arliss Street (MD 594D) from Walden Road to Flower Avenue (segment two); and on the west by the east side of Flower Avenue from Arliss Street (MD 594D) to the south side of East Franklin Avenue.
- (5.) Long Branch Bounded on the north by the south side of East Franklin Avenue from Seminole Street to University Boulevard East (MD 193); on the east by the west side of University Boulevard East (MD 193) from East Franklin Avenue to East Wayne Avenue; on the south by the north side of East Wayne Avenue from University Boulevard East (MD 193) to Long Branch Parkway; and on the west by Long Branch Parkway from East Wayne Avenue to Dearborn Avenue segment one; and Seminole Street from Dearborn Avenue to East Franklin Avenue (segment two).

- (6.) Montgomery Knolls Bounded on the north by the south side of Malibu Drive between University Boulevard East to the west side of Weaver Street; on the east by the west side of Weaver Street between Heron Drive and Patton Drive and the west side of Weaver Street between Malibu Drive the south side of Daleview Drive; on the south by Miles Street from Patton Drive to Langley Drive (segment one), Heron Drive from Langley Drive to University Boulevard East (MD 193) (segment 2), and on the west by the east side of University Boulevard East (MD 193) from Glenville Road to Buckingham Drive.
- (7.) New Hampshire Estates Bounded on the north by Ruatan Street from Quebec Street to the Prince George's County Line; on the east by the Prince George's County line from Ruatan Street to Merrimac Drive; on the south by the north side of Merrimac Drive from the Prince George's County Line to University Boulevard East (MD 193); and on the west by the east side University Boulevard East (MD 193) from Merrimac Drive to Carroll Avenue (segment one), the east side of Carroll Avenue from University Boulevard East (MD 193) to Piney Branch Road (MD 320).
- (8.) Rolling Terrace Bounded on the north by the south side of Gilbert Street from Barron Street to University Boulevard East (MD 193); on the east by the west side of University Boulevard East (MD 193) from Gilbert Street to Forston Street; on the south by Forston Street from University Boulevard East (MD 193) to Barron Street; and on the west by Baron Street from the southern property line of 8310 Barron Street to the south side of Domer Avenue (segment one), and the east side of Barron Street from Domer Avenue to Gilbert Street (segment two).
- (9.) Kilmarock Bounded on the north by Chester Street from Prospect Street to Carroll Avenue (MD 195); on the east by west side of Carroll Avenue (MD 195) from the northern property line of 8114 Carroll Avenue (MD 195) to the southern property line of 7900 Carroll Avenue; on the south by Glenside Drive from Carroll Avenue (MD 195) to Prospect Street; and on the west by Prospect Street from the road terminus west of Glenside Drive to the road terminus north of Chester Street.

- (10.) Sligo Park Hills Bounded on the north, east, and south by the City of Takoma Park Incorporated Boundary; and on the west by the east side of Piney Branch Road (MD 320) from Parkside Road to the northern property line of 8319 Piney Branch Road (MD 320).
- (11.) Park Knolls Bounded on the north by Piney Branch Road (MD 320) from the east side of Flower Avenue (MD 787) to Arliss Street (MD 594D) (segment one), the south side of Garland Avenue, from the east side of Arliss Street (MD 594D) to the road terminus (segment two), on the south side of Piney Branch Road (MD 320) from Garland Avenue to University Boulevard East (MD 193) (segment three); on the east by the west side of University Boulevard East (MD 193) from Piney Branch Road (MD 320) to Gilbert Street, the north side of Gilbert Street from University Boulevard East (MD 193) to Barron Street, the west side of Barron Street from Gilbert Street to Domer Avenue, Garland Avenue from Domer Avenue to Clayborn Avenue, Haddon Drive from Clayborn Avenue to Houston Avenue; on the south by the north sides of Houston Avenue from Haddon Drive to Flower Avenue (MD 787); and on the west by the east side of Flower Avenue (MD 787) from Houston Avenue to Piney Branch Road (MD 320).

Flower Avenue Park Bounded on the north by the south side of Houston Avenue from Flower Avenue (MD 787) to the eastern property line of 1005 Houston Avenue; on the east by Garland Avenue from Houston Avenue to the City of Takoma Park Incorporated Boundary (segment one), the west side of Long Branch Parkway from Maplewood Avenue to Carroll Avenue (MD 195); on the south by the west side of Carroll Avenue from Long Branch Parkway to the City of Takoma Park Incorporated Boundary (segment one), the City of Takoma Park Incorporated Boundary from Carroll Avenue (MD 195) to Flower Avenue (MD 787) (segment two); and on the west by the east side of Flower Avenue (MD 787) from the north side of Division Street to Houston Avenue.
