## MAJOR TRANSPORTATION PROJECTS IN SILVER SPRING: A dialogue with newcomers to the community

The Silver Spring Citizens Advisory Board invites you to their regularly scheduled monthly meeting Monday, November 9th, 6:40 p.m.\* at the Silver Spring Civic Building. (\*Note that this is an earlier start time than the usual 7:00 p.m.)

This dialogue will focus on the functional aspects of the Purple Line Light Rail system that will run through the middle of the Silver Spring Regional Area; and, the Bus Rapid Transit system proposed to be built on US29 and New Hampshire Road.

• The focus of the dialogue will be to better understand the context for these projects; how they relate to each other - and other transportation projects, programs, and initiatives; and, how the systems will operate.

The Silver Spring Citizens Advisory Board invites particularly community members that may not be as familiar with these projects, are new to the area, or want to remain informed as these processes move forward. (There are other on-going processes and venues for in-depth information and inquires on specific hyper-local issues. This SSCAB dialogue will focus more on general and contextual information for residents that are not as familiar with these projects.)
