Create a Balanced Transportation System

State road network project status

- I-270 Integrated Corridor Management under construction
- I-270 / I-495 Managed Lanes Project alternatives retained for detailed study (including MD 200 diversion alternative)
- I-270 / Watkins Mill Interchange under construction
- BRAC Intersection Improvements / MD185 at Jones Bridge Road utility relocation in process
- MD 97 at Randolph Road Interchange complete
- MD 97 / Montgomery Hills study phase nearly completed
- MD 97 / Brookeville Bypass under construction
- US 29 Mobility & Reliability Study results expected fall 2019

- Real time transit screens










Create a Balanced Transportation System

Transit: Purple Line

- 16.2 miles under construction across the alignment from Bethesda to New Carrollton. Projected to last through 2022.
- Includes the Capital Crescent Trail, Bethesda South Metro Entrance, and the Silver Spring Green Trail
- Purple Line Transit Partners concessionaire is one of the largest public private partnerships in the country






Create a Balanced Transportation System

Transit: US 29 FLASH BRT

- 14 mile corridor
- 11 BRT stations
- 40% of alignment on US 29 in dedicated Bus on Shoulder
- Construction funding:
 \$10 million Federal TIGER grant;
 \$21 million County funds
- 12 platforms now under construction
- Start of service: May 2020








Create a Balanced Transportation System

MD 355 FLASH BRT

- 22-mile corridor
- 28 BRT stations
- County completed a review of the conceptual alternatives – summer 2019
- Results shared with County Council
- MCDOT received funding (\$3M) to advance the project into preliminary engineering in FY20






Create a Balanced Transportation System

Transit: MD 586 BRT

- 6 mile corridor
- 11 BRT stations
- Extension up to Montgomery College along MD 355
- Recommended alternative selected in 2017
- Funding approved in CIP to complete preliminary engineering in FY20 and FY21






Create a Balanced Transportation System

Transit: Corridor Cities Transitway

- Phase One is 9 miles
- 13 FLASH BRT stations
- 30% design complete
- Future phases dependent on funding availability





Create a Balanced Transportation System

Metrorail and Metrobus

- Eliminated all Metrorail turnbacks at Grosvenor (2018) and Silver Spring (2019)
- Working with MCDOT on new station entrances: Medical Center & Bethesda
- Funding from MD, DC and VA to support state of good repair
- Continued early rail system closures for nighttime maintenance/repair
- Studying joint development opportunities at Rockville, White Flint, Grosvenor and Forest Glen stations


Reedie Dr at Grandview Ave – Geometric Improvements, design completed

Street Lighting

- Converting all existing County owned lights from HPS to LED scheduled for completion in 2020
- Installing 50 additional lights within the CBD and surrounding vicinity, a multi-year, development-related effort expected to completed by 2022.










Mid-County Pedestrian & Bike Improvement Projects

 - Signals







Emory Lane / Muncaster Mill Road Path

- Key Missing Link between Needwood / Rock Creek Trails, ICC Path & Shady Grove Metro
- Includes path along Emory Lane and Muncaster Mill Road (MD 115) and new full Signal across MD 115
- Connects to MNCPPC Montgomery Parks North Branch Trail (funded connection from Muncaster Mill Rd to Rock Creek Trail)
- Contributions from MDOT State Bikeways Program and MNCPPC Montgomery Parks
- Design underway; Construction Start anticipated 2020-2021
- \$2.6M through FY22 (Bikeways Minor Improvement Program)






Mid County Engineering Projects

Forest Glen Passageway

- A grade separated connection under Georgia Avenue to improve access to the Forest Glen Metro station from neighborhoods and institutions on the east side of Georgia Avenue.
- A new connection to the existing underground walkway from the northeast quadrant to the southwest quadrant of the intersection.
- A ramp connection and elevators will be located at the northeast corner of the intersection.
- Preliminary design programmed to start in FY21.








Mid County Engineering Projects

Gold Mine Road Bridge

- Replacement of existing bridge over Hawlings River.
- The new bridge will carry 2 lanes of traffic, improve sight distance, raise the bridge elevation to reduce flooding, removes vehicle weight restrictions and provide pedestrian facilities.
- Bridge opened to traffic in August 2019 prior to the new school year.





- Completed August 2019



Parking Operations Updates


LED Light Replacement Project

- 37,000 existing fixtures replaced in PLD parking facilities
- 1.4 million kWh savings annually

Replacement of single space meters in small surface lots

 Provides more payment options for parking customers, including coins and credit cards and Pay by Cell

Expansion of ParkMobile Payment application in master meter garages.


























