DGS is beginning a major HVAC project at the 4th district police station in 2024 so during that the functions will be moving to the 8th floor of the Wheaton HQ building. Holding cells, processing and similar functions will go to other stations for 12-14 months. The question police wants to pose is whether to move the whole precinct functions into the Wheaton HQ building retail space.

Gary – we should think about the spaces required for police vehicles and what's needed for that. Also the question of what kinds of offenders would be in place there, since it's a fairly exposed location with lots of glass. I imagine it would be a lot more expensive to be done right.

Rob – To confirm, holding cells would be in there as well?

Luisa – yes they would

Arquilla = I'd like to see them stay where they are and am against them moving. In that area of Glenmont there's a safety light there so there's a need there.


Kathia for CM Nati Fani Gonzalez – Drone program went to the public safety committee and passed. The next vote is coming up early November so we'll find out what happens then. Exploring a Wheaton A&E advisory board group as well.


David Lorenzo for CM Glass – Safe streets act finally became law. This will improve traffic safety around the county in a variety of ways. Suicide awareness and firearms prevention act, requiring gun retailers in MoCo to provide information at the point of sale on suicide prevention. Firearms are the leading source of suicide in MD and Nationwide.

Serge – With regard to the gas powered leaf blowers, how is the county helping businesses that have a lot of people using the old blowers?

David – that is central, and part of why we waited so long was to make sure we had something good for a reimbursement program. We're looking to reimburse someone up to 60 or 80 percent for the cost of a replacement.

Ana Arriaza, DEP – we are working really hard to get information out and to make sure whatever program is designed it takes into account some of the challenges smaller companies will be facing. We just put a link to the survey into the chat.







Jim Frank DEP – Recycling investigations unit with himself and 5 additional staff
