Introductions (roll call of those presence, quorum not reached)

Background – The county council was examining the allocation of transportation in the County Executive's budget. In lieu of full funding for the Montrose Parkway extension other projects, including the Viers Mill BRT, second Forest Glen metro entrance, and bike/pedestrian projects in Wheaton, among others, could be funded. Many expressed concerns about falling traffic demands at Montrose and Viers Mill and Amazon's impact.

<u>Update</u> – The County Council will vote to pass a compromise tomorrow, March 20, to delay the Montrose Parkway extension for one year, and fully fund other transportation projects, to study the impact on pedestrian safety.

- Forest Glen second entrance
- Viers Mill BRT
- Planning for New Hampshire BRT
- Whit Flint North Metro entrance for Pike & Rose
- Burtonsville project
- BIPD (bicycle & pedestrian) infrastructure in Wheaton & Glenmont
- Dale Drive safety improvements
- Land procurement for Observation Drive
- \$20 million for MCPS CIP
