

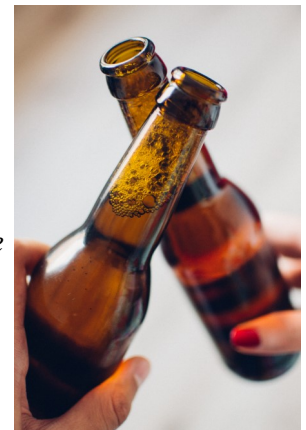
Retail Delivery

General Provisions:

- The [Board of License Commissioners](#) may authorize holders of a Class A, Class B, Class BD, or Class D off-sale license to make beer and wine deliveries within the boundaries of Montgomery County.
- License holders must get a letter of authorization from the Board; comply with the [Rules and Regulations](#) of the Board of License Commissioners; and get an Off-premises Delivery Written Certification from each customer receiving delivery.

Specific Requirements under Section 5.9 of the Rules and Regulations of the Board of License Commissioners:

- Retail deliveries are only permitted if the licensee obtains a letter of authorization from the Board of License Commissioners to make deliveries, and complies with all the provisions regarding delivery contained in this regulation.*
- Licensees are prohibited from contracting out for the off-premises delivery of alcoholic beverages to an independent delivery or courier service.*
- The delivery must be made from the licensed premises and may only be made within Montgomery County.*
- The licensee or the licensee's agent making the delivery must be at least eighteen (18) years of age.*
- The licensee or the licensee's agent making the delivery can only deliver the alcoholic beverages to an individual who is twenty-one (21) years of age or older, after the person taking possession of the alcohol presents the deliverer with a valid identification showing the individual's photograph and date of birth.*
- The person taking possession of the alcoholic beverages must sign a written certification as set forth in the Alcoholic Beverages Article, Section 4-506, detailing the valid form of identification presented to the deliverer.*
- The licensee must retain all written certifications on the licensed premises for at least one (1) year, and must make the certifications available for inspection by an authorized representative of the Board of License Commissioners during regular business hours.*



OFF-PREMISES DELIVERY WRITTEN CERTIFICATION

The Board of License Commissioners for Montgomery County requires that anyone purchasing alcoholic beverages off-premises must be twenty-one (21) years of age or older, and show proof of age, regardless of age. In order to comply with this rule, we ask that you please complete the section below.
