#### **ACTION ITEMS:**

1. Minutes of July 27, 2022, Worksession.

**2.** A-6693 [CU 21-06], Petition of Reflections Inc. (Variance). Now that the Hearing Examiner's June 16, 2022, Report and Decision on Remand in CU Case No. 21-06, is final, the Board will consider the Hearing Examiner's October 11, 2021, Recommended Decision in Variances.
