Mental Health Definitions

METRIC	DEFINITION
CIU Avg Census Female	The average monthly census of all inmates at MCCF admitted to the female CIU pod.
CIU Avg Census Male	The average monthly census of all inmates at MCCF admitted to the male CIU and step-down pods.
# Referrals to CIU	The monthly total of mental health referrals received and responded to by the CIU therapists at MCCF.
CIU Admissions: Female Unit	The monthly total of inmates assessed and admitted to the CIU female pod at MCCF.
CIU Admissions: Male Unit	The monthly total of inmates assessed and admitted to the CIU male pod at MCCF.
Total Admissions to CIU (Crisis Intervention Unit)	The monthly total of inmates assessed and admitted to both the male and female CIU pods at MCCF.
Discharges from CIU	The monthly total of inmates discharged from both the male and female CIU pods to GP at MCCF. (Doesn't include transfers to step down unit transfers)
Recidivists to CIU	The monthly number of newly admitted inmates to CIU at MCCF who had been admitted to the unit on a previous incarceration.
Adjustment Hearings	The number of Adjustment Hearings heard on inmates who had been admitted to and were housed in CIU at the time of the hearing that month
Certs to State Hospitals	The number of inmates at MCCF who required referral for involuntary hospitalization
Court Orders to State Hospitals	The number of inmates at MCCF who were court ordered to a hospital that month.
15 Minute Watches	The number of male and female inmates at MCCF who required to be on a 15 minute observation status.
Suicidal Gestures/Attempts	The number of male and female inmates at MCCF who attempted to self injure or committ suicide that month.
MCCF Initial Psych Consults	The number of initial psychiatric assessments of inmates at MCCF that month.
MCCF F/U Psych Consults	The number of follow up psychiatric assessments of inmates at MCCF that month.
MCDC Initial Psych Consults	The number of initial psychiatric assessments of inmates at MCDC that month.
MCDC F/U Psych Evals	The number of follow up psychiatric assessments of inmates at MCDC that month.
Chart Reviews by Psychiatrist	The number of chart reviews by the psychiatrist of MCCF/MCDC inmates that month.
Total Psychiatric Referrals	The total number of inmates assessed by the psychiatrist that month (initial + follow up assessments)
Inmates Added to HSDB List (History of Self-Destructive Behavior)	The number of inmates added to HSDB List of MCCF/MCDC inmates that month.
Psychotherapeutic Groups	The number of therapy groups conducted by mental health therapists in MCCF that month.
Participants in CIU Groups	The total number of inmate participants in each of and all of the therapy groups conducted at MCCF that month.
Homeless Admitted to CIU	The number of homeless individuals admitted to CIU that month as identified by HHS or DOCR staff.
Inmates on Food/Weight/Sleep Logs	The number of inmates at MCCF who had to be placed on a Food/Weight/Sleep Log as determined by a mental health therapist during that month.
Suicides in MCCF	The number of successfully completed suicides at MCCF that month.
Suicides in MCDC	The number of successfully completed suicides at MCDC that month.
Suicides in CIU	The number of successfully completed suicides in CIU at MCCF that month.
