



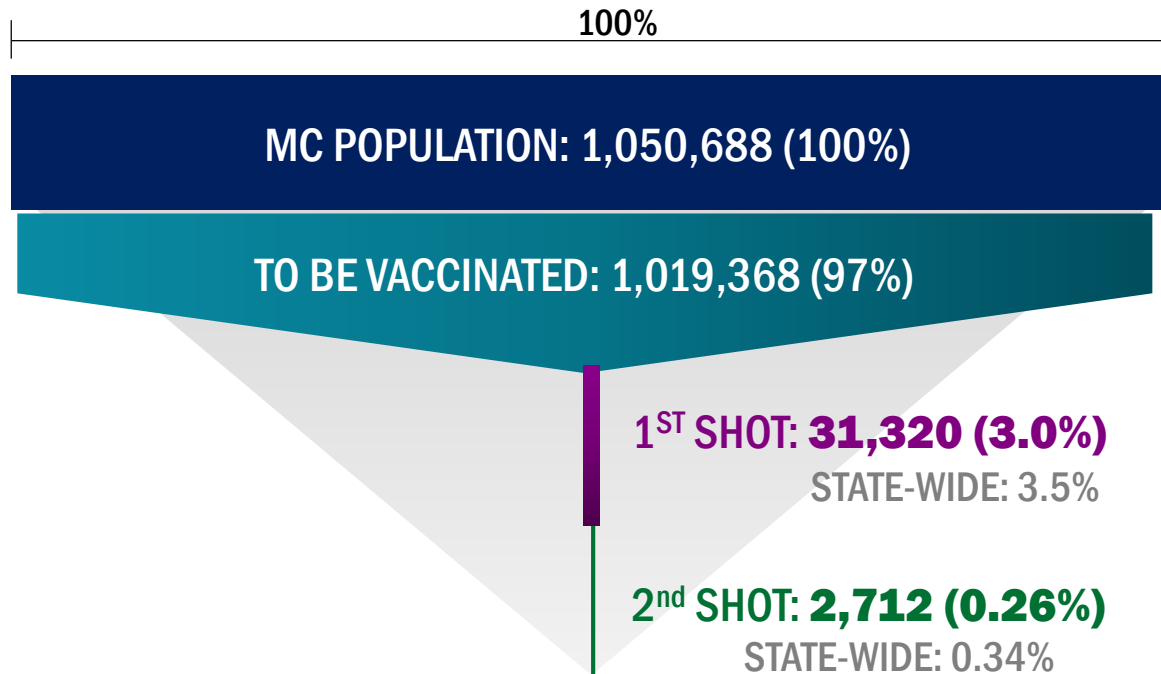

State-wide, Hospitals account for 47% of administered vaccines, Local Health Departments account for 36%, and CVS/Walgreens/Fed and "Other" account for the remaining 17%.

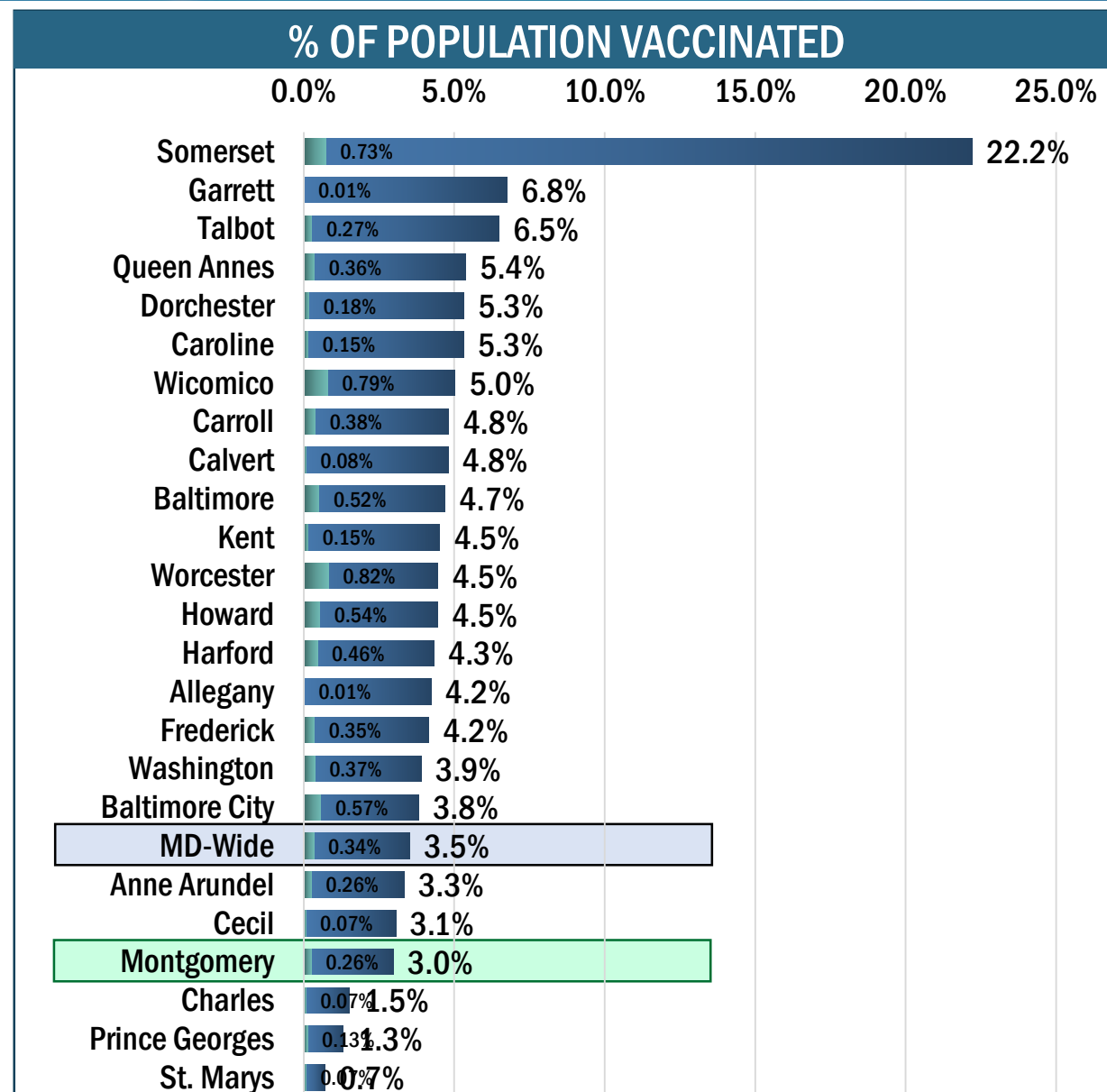

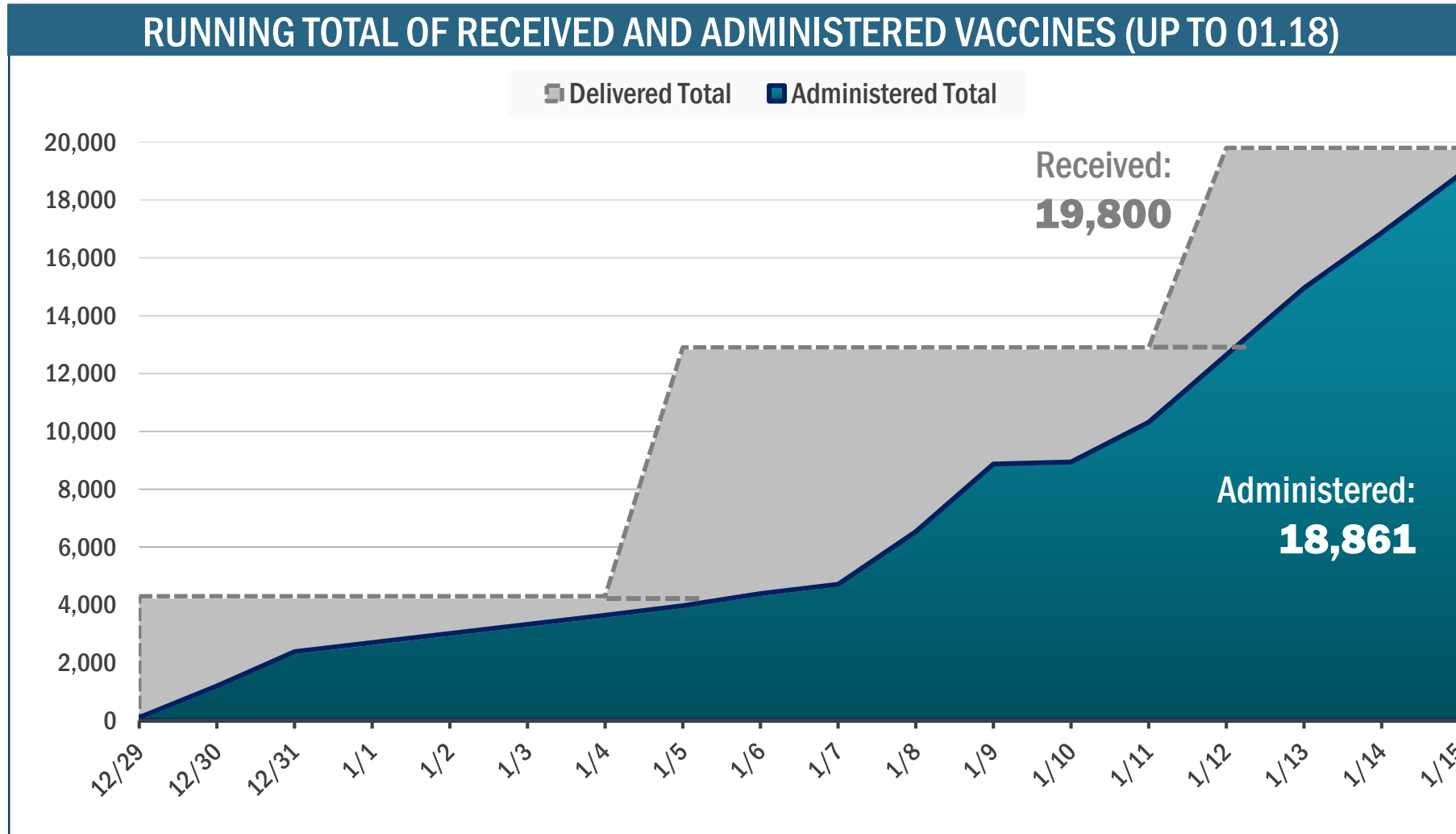

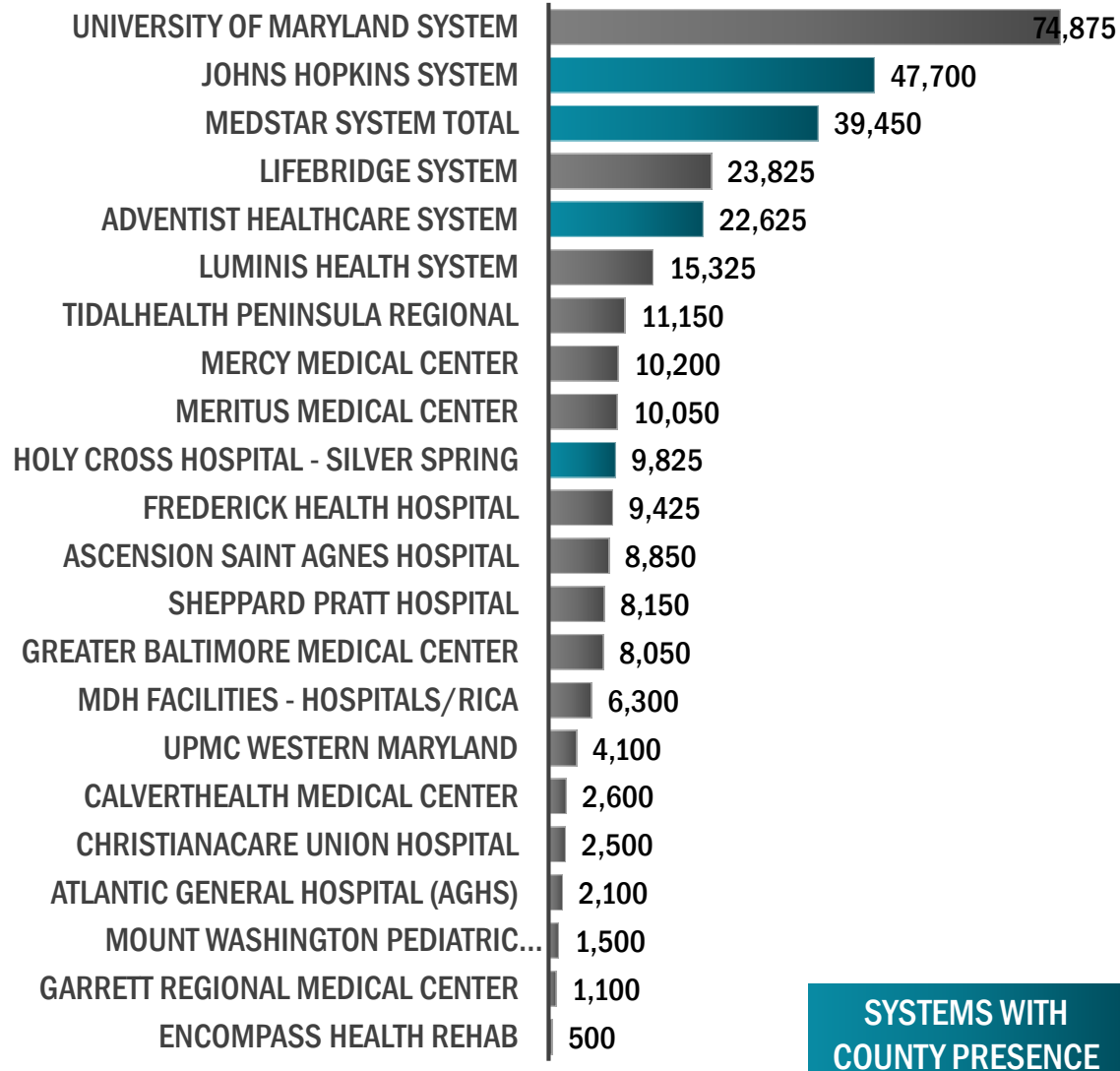

# OF VACCINES RECEIVED AND ADMINISTERED BY MD COUNTY HEALTH DEPARTMENTS (UP TO 01.17)

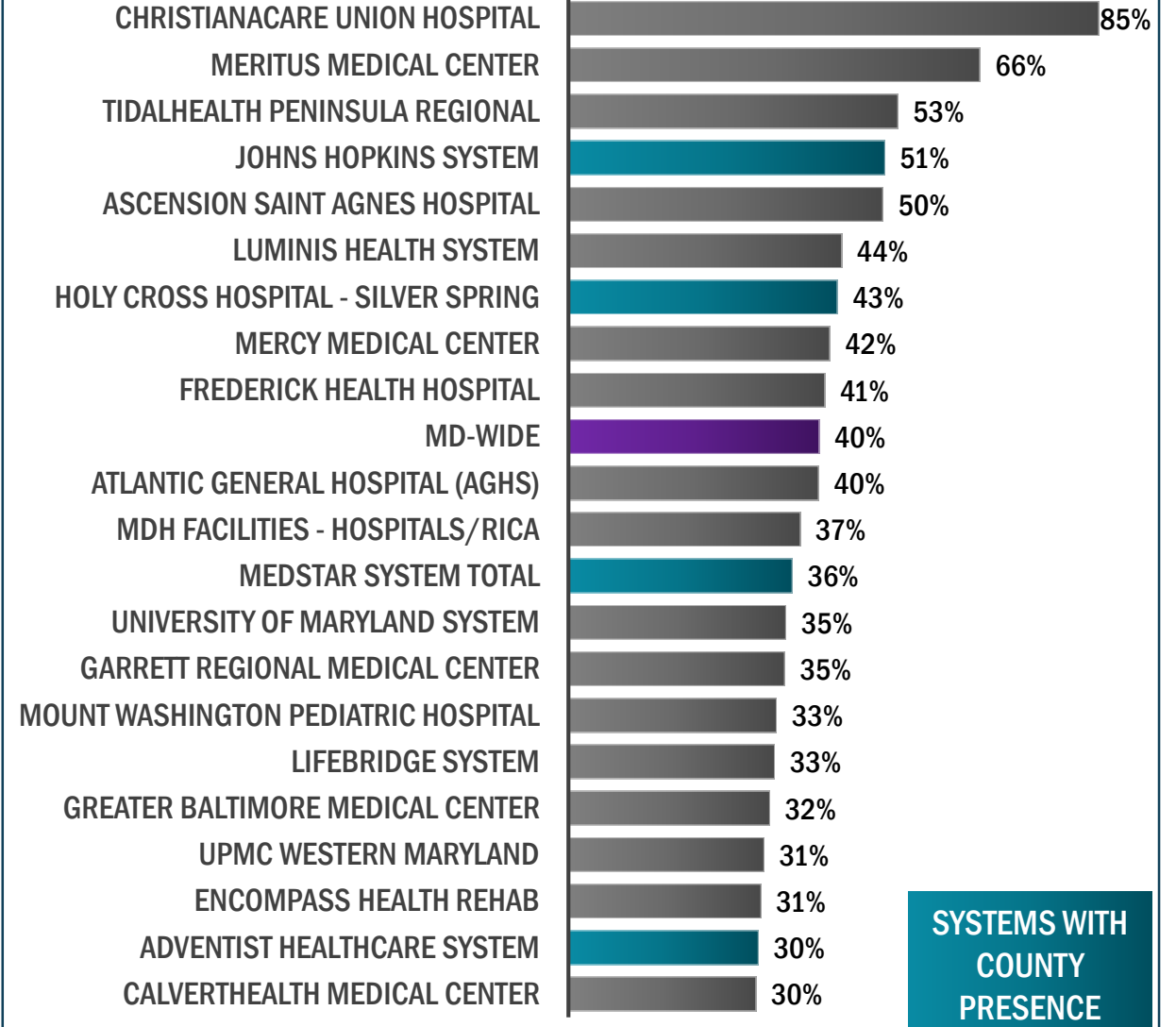


# HOSPITAL-ADMINISTERED VACCINES: SYSTEMS WITH COUNTY PRESENCE
