Meeting was called to order at 6:36PM.

#### I. Attendance and Administrative Items (6:36 PM)

- Logan Anbinder (LA) took attendance and Susan Farag (SF) began recording the meeting. SF confirmed that seven PAC members were present, which represents a quorum.
- Total: 24 attendees
- Meeting agenda was approved without objection.

### II. Guest Speaker – Effective Law Enforcement for All (6:40 PM)

- Mr. Sterling asked for the record to reflect that no police management representative
  was present on the evening of the ELEFA briefing. Asst. Chief Francke joined the
  meeting in this role some time after this comment was made.
- Dr. Burns and Mr. Douglass gave a presentation on the final draft report of the Effective Law Enforcement for All (ELEFA) audit of MCPD, and answered commissioners' questions. In addition to the areas of focus covered in ELEFA's

- preliminary report, the final report included a body-worn camera (BWC) review, district leadership interviews, and an MCPD systems and technology assessment.
- ACTION: At Ms. Branson's request, Mr. Douglass indicated that he would provide a list
  of community stakeholders with whom the draft audit has been shared. Council Staff
  will follow up.

## III. New Business (7:37 PM)

- No commission members have nominated themselves for the vacant position of vice chair. Ms. Branson reiterated her encouragement from last meeting that a commission member nominate themselves.
- The meeting minutes from April, July, and August were approved without objection.
- **VOTE:** PAC determined (8-0, with Ms. Fredrickson having left the meeting before this vote) to send a letter to CE Elrich requesting more information regarding the MOA signed with FOP, with technical corrections as mentioned by Ms. Branson and reference to OLO's 2021 report on the FOP CBA.
- **ACTION:** PAC will send aforementioned letter.
- **ACTION:** SF will invite Bishop Walker of the Police Accountability Board (PAB) to attend the next PAC meeting on October 10<sup>th</sup> to discuss opportunities for collaboration between the PAC and PAB.
- **ACTION:** PAC members were encouraged to think about a topic and venue for the PAC's mandatory annual public forum for this year.
