#### IV. New Business

- Chief Jones spoke and shared on current trends on traffic safety and enforcement.
- Mr. Ricks spoke in favor of the law that requires drivers to have headlights on while wipers are on as a means for reducing traffic incidents.
- Mr. McKinney discussed his impression that the speakers tonight asked for a balance between law enforcement intervention and automated enforcement, and emphasized the importance of striking that balance. He also thanked the police officials who participated.
- Mr. Gaster also thanked the MCPD officials who participated. He encouraged the use of additional data from other jurisdictions as points of comparison to the data from practices in the County.
- Ms. Daphnis spoke in favor of automated traffic enforcement and slower traffic speeds. She emphasized the importance of continuing non-enforcement, interagency work and using technology to reduce collisions.
- Ms. Ekstrand advocated for the use of data and analysis to develop effective solutions.
- Capt. Dillman spoke in favor of a holistic approach to traffic enforcement.
