Marijuana Arrests

Background:

On 4/12/21 during the regular monthly PAC meeting a document was presented by Mr. Sterling documenting and discussing the marijuana prosecution policy of the State's Attorney's Office and the arrest data / policy of the Montgomery County Police. The document and the information shared during the meeting portrayed that MCPD had 5030 marijuana arrests in 2018 and 3715 arrests in 2019. Based on the data presented Asst. Chief Patil believed that the numbers were not consistent with a physical arrest. Asst. Chief Patil was asked by the PAC to look into the situation and report back to the PAC by 4/19/21.

Findings

Asst. Chief Patil met with MCPD records and crime analysis staff to discuss the questions regarding the data, and these are the results of those meetings.

- 1. MCPD reports crime statistics to the FBI via the Maryland State Police.
- 2. The Maryland State Police report statewide crime data in the Uniform Crime Report format (Not NIBRS). This methodology uses hierarchy; thus a marijuana "arrest" would be one that could have underlying lower offenses as well.
- 3. The data reported "Crime In Maryland 2019 Uniform Crime Report" does not differentiate between a civil citation vs. a criminal arrest. It reports the "arrest" if the agency reports it as an arrest.
- 4. MCPD learned that although MCPD was directed by MSP to report civil & criminal charges as "arrests", Prince George's County Police does not, which would account for the significant difference in the agencies marijuana arrest numbers.
 - a. MCPD is following up to see if reporting rules may have changed. If so MCPD will adapt their reporting practices as appropriate.
- 5. MCPD does not have the ability to segment data related to whether a civil charge was placed vs. criminal arrests in the current records management system.
- 6. MCPD evaluated the MCPD data regarding marijuana cases where charges were placed, that was reported to the Maryland State Police (MSP).
 - a. MCPD determined that the numbers did not match what is reported for Montgomery County in the "Crime In Maryland 2019 Uniform Crime Report". (see chart below)
- 7. A spot check of MCPD marijuana "arrest" cases revealed that approximately 95% of the marijuana cases with charges were civil violations only. (under 10 grams). The Records staff pulled one random case per month in 2018 & 2019.
