Today the Education Committee will consider a supplemental appropriation to the Montgomery County Public Schools (MCPS) FY13 operating budget, \$1,000,000 for the Food Services Enterprise Fund. The Committee will also receive an update on and discuss recent efforts to increase State funding for the school breakfast program Maryland Meals for Achievement (MMFA). ## Update: School Breakfast Program

Maryland Meals for Achievement (MMFA) is a State funded program that provides universal breakfast in public schools which have at least 40 percent of students eligible for Free and Reduced Meals (FARMS). The breakfast is provided to all students in the classroom, which significantly increases participation and access to nutrition for students.

In November 2012, Committee Chair Ervin led an effort for both the Montgomery and Prince George's County Delegations to send a letter to Governor Martin O'Malley and State Superintendent Lillian Lowery advocating for increased funding for the MMFA program to allow more schools statewide to participate. Both letters are attached at circles 5-11, and Superintendent Lowery's response is attached at circle 4.

Governor O'Malley included the requested \$1.8 million increase in funding in his FY14 budget for the Maryland State Department of Education. This increase is expected to bring the Statewide total funding to approximately \$5.2 million and expand the program to an estimated 130 additional schools statewide. Related materials are attached at circles 1-3.

Montgomery County has a total of 82 schools eligible for MMFA, and currently 40 participate and receive funding. The Council has been following this issue closely for several years, and has worked with the Board of Education to ensure that all eligible schools apply each year regardless of the amount of funding available Statewide. A list of the participating Montgomery County schools is attached on circle 13.

The Montgomery County Board of Education has included support for expansion of the MMFA program in its legislative platform for at least six years. The Board's 2013 legislative platform states that the Board supports "Expansion of Maryland Meals for Achievement as an entitlement to include all eligible schools that choose to apply" and opposes "Limiting the number of eligible schools from participation in Maryland Meals for Achievement."

## **Supplemental Appropriation**

The Council introduced this supplemental appropriation on January 15 and held a public hearing on January 29 (there were no speakers). The Board of Education requested this appropriation on November 13 (transmittal attached on circles 18-20) and the County Executive recommended approval on December 11 (transmittal and approval resolution attached on circles 14-17).

The source of funds for this appropriation is Federal and State funds. The appropriation has three components:

- **\$560,000 from the United States Department of Agriculture (USDA)** in response to the final ruling on the Healthy Hunger Free Kids Act. Funds will assist MCPS in providing menu options with fewer processed foods, more whole grains, fresh salads, and increased vegetarian choices. MCPS provided additional description of the requirements on circle 12, including the cost implications. While the Federal reimbursement provides an additional \$.06 per meal for compliance, MCPS estimates that the implementation cost will be higher. MCPS states that it expects to maintain the enterprise fund without a loss through increased participation and continuing cost control measures.
- **\$107,000 from the State MMFA program** which will partially fund the cost for eight additional schools in this school year. As noted above, a total of 82 MCPS schools are eligible for the program. Each year all apply, and currently 40 schools receive funding.
- **\$333,000 from additional Federal reimbursement** because of an increase in the number of students eligible for Free and Reduced Meals (FARMS). Committee members are aware that MCPS enrollment of students eligible for FARMS continues to increase each year, and that currently approximately one-third of all MCPS students are eligible for this program.

## Council staff recommends approval of the supplemental appropriation as requested.

## Governor O'Malley Recommends Expanding 'Maryland Meals for Achievement' by Including Additional \$1.8 Million in FY14 State Budget, as Requested by Montgomery Councilmember Ervin and Coalition of Elected Leaders

*Councilmember Ervin Applauds Governor O'Malley's Commitment to Increasing Universal Breakfast for Students* 

ROCKVILLE, Md., January 16, 2013—Montgomery County Councilmember Valerie Ervin, who chairs the Council's Education Committee, worked with members of the Maryland General Assembly, the Maryland Partnership to End Childhood Hunger and Share Our Strength's No Kind Hungry Campaign to advocate for expanded funding for the Maryland Meals for Achievement (MMFA) Program, which Governor Martin O'Malley included in his recommended Fiscal Year 2014 State Budget that was released today.

Governor O'Malley's recommended budget contains an additional \$1.8 million in the FY14 Maryland State Department of Education budget to fund universal breakfast. This means an additional 56,896 children in Maryland could receive the benefit in schools across Maryland.

"I have been working on this issue for years, and I was ecstatic when I heard that Governor O'Malley had included the additional funding that we had advocated for in the Maryland Meals for Achievement Program," said Councilmember Ervin. "This is another example of how Governor O'Malley continues to provide the building blocks necessary for the success of our children."

Maryland Meals for Achievement is a national model for increasing access to the School Breakfast Program (SBP), with proven links to improved educational performance, health and behavior. It allows schools that have at least 40 percent of their student population

eligible for free or reduced-price meals (FARMS) to provide universal, in-classroom breakfast.

Councilmember Ervin joined with the Maryland Partnership to End Childhood Hunger, Share Our Strength's No Kid Hungry Campaign and members of the Montgomery and Prince George's Delegations to the General Assembly in a letter advocating for the increased funding. Every member of the Montgomery County Delegation and nearly all of the Prince George's County Delegation signed onto the request.

In December, State Senator Jamie Raskin and Delegate Susan Lee from Montgomery County, Delegate Aisha Braveboy from Prince George's County and Board of Education President Chris Barclay joined Councilmember Ervin at Roscoe Nix Elementary School in Silver Spring to highlight the importance of the universal breakfast program for students.

"Providing nutritious meals is one of the most immediate and cost-effective ways to improve a child's health and performance in the classroom," said Councilmember Ervin.

In MMFA schools, such as Roscoe Nix Elementary, the average participation in school breakfast is close to 70 percent. That is significantly higher than school breakfast participation in non-MMFA schools. Low-income children are at great risk of experiencing food insecurity, and often, the meals that they do receive outside of a structured program lack the vitamins and nutrients essential for their development. The lack of good nutrition can have a dramatic impact on student achievement.

"The groundswell of support from elected officials illustrates how much of an impact this program has on the lives of children," said Councilmember Ervin. "I am thankful for the many partners we have at the federal and state levels to support summer food and universal breakfast in Montgomery County, and I am extremely hopeful that the General Assembly will fund the Governor's recommendation in the budget."

In Montgomery County, more than one out of every seven children is at risk of hunger. Over the last three academic years, the number of children qualifying for free or reducedprice meals in the county has increased more than 25 percent with more than 47,000 children now falling below 185 percent of the federal poverty level. Currently, Montgomery County has more than 80 schools that meet the criteria to participate in MMFA, but because of funding levels, only 40 schools are benefiting from the program this school year.

Governor O'Malley is known for his commitment to ending childhood hunger in Maryland. Through the Partnership to End Childhood Hunger in Maryland and the dedicated support of Share Our Strength's national No Kid Hungry Campaign, Gov. O'Malley, over the course of his administration, has proven to be a staunch champion for children struggling with hunger. His commitment is vital in the fight to ensure that all of the nearly 237,000 Maryland children at risk of hunger have the foundation for a bright and healthy future.

Gov. Martin O'Malley listened to the local elected officials and 23 organizations he heard from last month asking him to increase state funding for a program that feeds breakfast to students at needy schools.

O'Malley announced his recommendation this week for \$1.8 million to be added to the state's budget for Maryland Meals For Achievement, which provides free breakfast for all students in their classrooms in schools that qualify.

This school year, the state is spending \$3.38 million for services that provide breakfasts to 33,000 students at 271 schools.

With the extra funding, the program would be expanded to serve 56,896 more children in about 130 more needy schools, bringing the total spent to \$5.18 million for 89,896 students in 407 schools.

O'Malley has made it a policy goal to end childhood hunger in Maryland by 2015 and has partnered with advocacy groups such as national nonprofit Share Our Strength and its No Kid Hungry campaign.

Maryland Hunger Solutions, one of the groups that wrote to O'Malley, said the funding recommendation demonstrates the governor's continued commitment.

The organization urges the General Assembly to support the increase, Cathy Demeroto, the director, wrote in a press release.

Led by Montgomery County Councilwoman Valerie Ervin, elected officials in Montgomery and Prince George's counties gathered in December to announce their request to O'Malley and the Maryland State Board of Education for the additional \$1.8 million.

Ervin (D-Dist. 5) of Silver Spring said in a press release Wednesday she was ecstatic to hear the governor's decision.

Providing the meals improves a child's health and performance in the classroom, Ervin said in the release.

Ervin is hoping that most of the money go to schools in Montgomery and Prince George's counties, where she says there is the most need. Of Montgomery's 80 schools that qualify, 40 currently participate.

It is up to the local school boards to advocate for the funding from the state's education board.

Montgomery County Public Schools Division of Food and Nutrition Services

January 16, 2013 Healthy Hunger Free Kids Act (HHFKA) (effective July 1, 2012):

The Healthy Hunger Free Kids Act (HHFKA) of 2010 authorizes funding for child nutrition programs and increases access to healthy food for low-income children. The act allows USDA to set nutritional standards for all food regularly sold in schools during the school day, including vending machines, a la carte sales and food items sold in school stores. Additional funding, \$.06 per meal, is provided to LEA's for compliance with the HHFKA. The HHFKA meal pattern requires that additional portions of fruits and vegetables be offered to students and at least 50% or more of grains offered are whole grain. Fluid milk must be 1% or fat free; flavored milk must be fat free; and water must be available to students during mealtime. In addition, in order to be considered a reimbursable meal, students <u>must</u> select ½ cup of fruit or vegetable. This is a first; students have always been afforded the opportunity to select 3 of 5 meal components.

Implementation of the HHFKA has resulted in a significant increase in food costs. Introduction of new vegetable choices include, zucchini coins, grape tomatoes, red pepper slices, celery slices, sliced cucumbers, baby spinach and romaine salad. A fresh garden salad has been added as an entrée twice a month in all elementary schools. As of December, 2012, fresh produce purchases have increased \$214,078 since December, 2011; reflecting a 46% increase.

Yogurt and hummus have been added as meal choices on menus. A new, whole muscle, unbreaded chicken bite, i.e. considered less processed, is priced \$.26 greater per serving than the breaded chicken nugget. An unbreaded bone-in chicken has been added as a replacement to a breaded product, at an additional cost of \$.13 per serving.

51% of all grains offered to students must be whole grain. A whole grain hamburger bun has been introduced at an additional cost of \$.05 per unit. As of December, 2012, bakery purchases have increased \$200,454 since December, 2011; reflecting a 30% increase.

DFNS revenue projections for FY 2013 include additional funding of \$.06 per lunch, resulting from HHFKA compliance, which will offset a portion of the added food costs. Food cost per meal is expected to increase \$.13 resulting in a \$.07 deficit per meal. The increase in revenue from an expected increase in student meal participation and continuing cost control measures will allow the enterprise fund to operate without a loss associated with these food cost increases.

### **MMFA Program Information:**

On November 13, 2012, the Board of Education requested to receive and expend an FY13 supplemental appropriation of \$1,000,000 for the Montgomery County Public Schools (MCPS) Food Services Enterprise Fund.

The FY13 Operating Budget for MCPS included an appropriation in the Food Services Enterprise Fund of \$47,476,295. Since the MCPS budget was approved, there have been several occurrences that will require additional expenditures by the Division of Food and Nutrition Services (DFNS) during the current and in subsequent fiscal years.

First, on March 26, 2012, the U.S. Department of Agriculture implemented its final ruling on the Healthy Hunger Free Kids Act (HHFKA). At the time the MCPS budget was approved, there was still uncertainty over the impact on FY13 food costs. This ruling updates meal patterns and nutrition standards for the National School Lunch Program by aligning them with the Dietary Guidelines for Americans. As a result, MCPS will offer menu options that offer fewer processed foods, more whole grain breads, fresh salads and salad bars, and increased vegetarian choices. Approximately \$560,000 will be provided by the USDA through the State of Maryland as a result of the HHFKA ruling.

Second, after the FY13 budget was adopted, eight MCPS schools were made Maryland Meals for Achievement (MMFA) Program schools. This addition provides breakfast at no cost to all students in the schools and will require the purchase of additional food for breakfast. DFNS will receive \$107,000 from the State to partially fund the program.

Third, additional federal reimbursement will be received as a result of an increase in the number of students eligible for the Free and Reduced-price Meals System program.

I recommend that the County Council approve this supplemental appropriation of \$1,000,000 from the USDA, State of Maryland, and federal Free and Reduced-price Meals system program. The source of funds will be Federal and State revenues.

2.	2. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after a least one week's notice. A supplemental appropriation that would comply with, avail the Count of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmember A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.

- 4. The Board of Education has stated that this appropriation is needed to receive and expend \$1,000,000 in the Food and Nutritional Services Fund, for the Montgomery County Public Schools Food and Nutritional Services Enterprise Fund. The Division of Food and Nutritional Services will receive approximately \$560,000 in additional federal revenue via the State of Maryland as a result of the Healthy Hunger Free Kids Act ruling, \$107,000 in additional revenue from the State for adding eight schools to the Maryland Meals for Achievement breakfast program, and additional federal reimbursements as a result of more students being eligible to participate in the Free and Reduced-price Meals System Program

## Recommendation in Brief

Authorization is requested to receive and expend, subject to County Council approval, a Fiscal Year (FY) 2013 supplemental appropriation of \$1,000,000 for the Montgomery County Public Schools (MCPS) Food Services Enterprise Fund. This supplemental appropriation will be funded by additional federal and state reimbursements.

Background

The amount budgeted for the Food Services Enterprise Fund for FY 2013 is \$47,476,295. Since the MCPS budget was approved by the County Council last May and adopted by the Board of Education in June, there have been several occurrences that will require the Division of Food and Nutrition Services (DFNS) to make additional expenditures during FY 2013 and in subsequent years.

The United States Department of Agriculture (USDA) implemented its final ruling on the *Healthy Hunger Free Kids Act* (HHFKA) on March 26, 2012. When the MCPS operating budget was approved last May, there still was uncertainty regarding the impact of this ruling on food costs. This ruling updates meal patterns and nutrition standards for the National School Lunch Program by ensuring that they are aligned with the Dietary Guidelines for Americans. Schools are required to increase the availability of fruits, vegetables, and whole grains; reduce sodium levels and saturated and trans fats in meals; and meet the nutrition needs of school children within their caloric requirements. These improvements to school meal programs are expected to enhance the diet and health of school children and help mitigate the childhood obesity trend. As a result, MCPS will offer menu options that offer fewer processed foods, more whole grain breads, fresh salads and salad bars, and increased vegetarian choices.

## Members of the Board of Education

After the FY 2013 MCPS budget was adopted, eight MCPS schools were added as Maryland Meals for Achievement (MMFA) Program schools, bringing the total number of participating schools to 40. This program provides breakfast, at no cost, to all students at these schools. This will require the purchase of additional breakfast food items.

Approximately \$560,000 of the revenue to support these expenditures will be provided by USDA through the state of Maryland as a result of the HHFKA ruling. DFNS will receive \$107,000 from the state of Maryland to partially fund the MMFA Program. Additional federal reimbursements will be received as a result of an increase in the number of students eligible to participate in the Free and Reduced-price Meals System Program.

### Use of Funds

The supplemental appropriation will be used to purchase food items that will provide healthier menus for students, including more fresh fruits and vegetables, whole grain bread items, yogurt, and other items that have less sodium and fat. Funds will be used to provide breakfast items, including milk and juice for the eight additional MMFA schools.

## Evaluation

As required by HHFKA, the Maryland State Department of Education will conduct a nutritional review of school lunches during the 2012–2013 school year. Certification will be based on compliance with the meal patterns and dietary specifications based on a two-week review of menu and production records. MCPS also conducts an annual audit of the Food and Nutrition Enterprise Fund using an external auditing firm, CliftonLarsonAllen.

#### **Recommended** Resolution

WHEREAS, The Fiscal Year 2013 budget for the Food and Nutrition Services Enterprise Fund is \$47,476,295; and

WHEREAS, There was uncertainty when the Montgomery County Public Schools budget was approved by the County Council last May and adopted by the Board in June, regarding the impact on food costs resulting from the final rule of the *Healthy Hunger Free Kids Act*, signed March 26, 2012; and

WHEREAS, As a result of the *Healthy Hunger Free Kids Act* ruling, schools are required to increase the availability of fruits, vegetables, and whole grains; reduce sodium levels and saturated and trans fats in meals; and meet the nutrition needs of school children within their caloric requirements, which will increase food costs; and

WHEREAS, Eight schools were added to the Maryland Meals for Achievement breakfast program for Fiscal Year 2013 after the Montgomery County Public Schools operating budget was adopted, which will increase the cost of breakfast items; and

WHEREAS, The Division of Food and Nutrition Services will receive approximately \$560,000 in additional federal revenue via the state of Maryland as a result of the *Healthy Hunger Free Kids Act* ruling, \$107,000 in additional revenue from the state for adding eight schools to the Maryland Meals for Achievement breakfast program, and additional federal reimbursements as a result of more students being eligible to participate in the Free and Reduced-price Meals System Program; now therefore let it be
