COMMISSION ON PEOPLE WITH DISABILITIES

Section 27-51 of the Montgomery County Code, 1978 (amended 1990, 1995). Created ---

Advise the County Executive and the County Council on matters relating to Purpose --

residents with disabilities of the County; review overall programs and services for people with disabilities, including identifying unmet needs and gaps in services; review federal, state and local legislation that affect people with disabilities; and identify, analyze and evaluate barriers to programs and services for people with disabilities. The Commission also studies ways to maximize the use of facilities and services available to people with disabilities; initiates and sponsors conferences, forums and special task forces to identify and assess needs and promote the coordination of services among public and private agencies that provide services and programs for people with disabilities; reviews budgetary recommendations for the County's contribution

to programs and services to disabled individuals; and, submits an annual

report.

25 members and at least 5 non-voting members. Thirteen of the voting Membership --

> members are to be people with disabilities; three members are to be parents of people with disabilities and nine members are to be representatives from organizations and agencies that provide services or represent people with disabilities. Five non-voting members including one from the Department of Recreation, Department of Public Works and Transportation, and the Human Rights Commission, and two non-voting members from the Department of

Health and Human Services.

Terms --Three year terms - no compensation.

Meetings --Second Wednesday of each month, except for July and August.

Leggett Seeks Applicants for Commission on People with Disabilities

County Executive Isiah Leggett is seeking applicants to fill seven vacancies on the Montgomery County Commission on People with Disabilities. Three vacancies must be filled by representatives of organizations or agencies that provide services to people with disabilities; three vacancies must be filled by representatives of people with disabilities; and one representative must be filled by a parent of a person with disabilities. Three incumbents are eligible to apply for reappointment (one organization representative; and two people with disabilities representatives).

The Commission advises the County Executive on programs and services concerning the nearly 190,000 residents with disabilities.

Members serve three-year terms without compensation, meeting the second Wednesday evening of each month at the Executive Office Building in Rockville. Members are expected to serve on at least one committee or work group that meets approximately once every month on its own schedule. Applicants of diverse backgrounds, professions, gender, geography, disability and ethnicity are encouraged to apply and should write by June 12 to County Executive Isiah Leggett at the Executive Office Building, 101 Monroe Street, Rockville, MD 20850 or send an e-mail to countyexecutive.boards@montgomerycountymd.gov. A brief resume, including home and work telephone numbers, should be enclosed detailing pertinent experience and business, civic or community group association. The cover letter should indicate the type of slot the applicant is applying for. Those applying for reappointment must indicate current employment or send an updated resume with your application letter.

Members of County boards, committees, and commissions may not serve on more than one such group at a time. Members of this Commission are eligible for reimbursement for travel and dependent care for meetings attended. Leggett's appointments are subject to confirmation by the County Council. Applications of those selected for appointment are made public as part of the confirmation process.
