<u>Health and Human Services (HHS) - \$373,957 for Legal Representation for</u>

Approved, without objection, Ms. Navarro's motion to include \$370,000 in the FY19 operating budget, rather than the FY18 budget, for screening and legal representation services for low-income County residents who are in deportation proceedings, and that the budget resolution restrict these funds for screening and direct legal representation and that when direct legal representation is provided. The exclusion policy for County-funded representation that is included in the amendments recommended by Council staff in the special appropriation resolution must be adhered to.

Ms. Navarro noted that this level of funding would also replace \$50,000 in funds that the County Executive included in his recommendations for community grants.
