# (10) **DISCUSSION - Compensation Cost Trends**

This item was postponed to November 15, 2018.

### **SALUTE** to County Executive Ike Leggett

Councilmembers recounted personal memories of working with Mr. Leggett over the years and expressed appreciation for his leadership and service to the people of Montgomery County.

Mr. Riemer presented a proclamation to Mr. Leggett in recognition of his many years of service to the County as a member of the Council and as County Executive.

# (11) **BRIEFING** - Pedestrian and traffic safety along State highways

Participating in the discussion were Mr. Slater, State Highway Administration (SHA); Captain Didone, Traffic Division Director, Department of Police; Mr. Roshdieh, Director, and Mr. Conklin, Department of Transportation (DOT); and Ms. Daphnis, Chair, Pedestrian, Bicycle, and Traffic Safety Advisory Committee.

Received a briefing from Mr. Slater on SHA's updated approaches to pedestrian safety including HAWK pedestrian signals, strategies to reduce vehicular speed, national and local statistics on pedestrian crashes, risk factors, and improvement projects to Georgia Avenue (Route 97) in Wheaton and Aspen Hill. He agreed to follow up with Councilmembers regarding specific intersections in the County.

Ms. Navarro asserted that a streamlined, coordinated method to address pedestrian safety issues must be developed as soon as possible to help prevent future accidents.

Mr. Rice suggested that when designing intersections, the routes of children walking to school be considered and an analysis of intersections on those

routes is needed to develop a standardized model for all school areas in the County. He also stated that a sidewalk is needed along Clopper Road because many people walk in the road.

Mr. Elrich, noting that speed is a major factor in crash survivability for pedestrians, suggested legislators be asked to lower the speed limit on roads in Central Business Districts (CBDs) currently designated as 30 miles per hour (mph) to 25 mph.

Mr. Katz suggested SHA consider installing bollards near bus stops as a traffic-calming measure and installing fencing in road medians to prevent jaywalking. He further stated that additional lighting at Falls Road near 270 is needed as the intersection can be confusing to drivers.

### **Motion to Close**

The Council adjourned the open session at 3:31 P.M. and reconvened in closed session from 3:35 P.M. to 4:25 P.M. in the Patuxent River Conference Room. Mr. Katz made the motion, which carried. Mr. Berliner, Mr. Elrich and Ms. Floreen were temporarily absent.

## 18A-36. Payment of surcharge; lien.

- (a) The County must collect the amount financed through a surcharge on the property owner's real property tax bill and forward payments received by the County to the County designated program manager or, if there is no County designated program manager, to the lender no later than 30 days after the payment due dates for real property taxes. Payment due dates for semi-annual real property taxes are September 30 for the first installment and December 31 for the second installment, and for annual real property taxes the payment due date is September 30.
- (b) After receiving written notice from the County designated program manager of the execution of a clean energy loan financing agreement, the County must add the surcharge to the property tax bill [[on July 1 of the year immediately following execution of the clean energy loan financing agreement]].
- (c) If the property owner sells the qualified property, the buyer must continue to pay the surcharge levied on the annual property tax bill.
- [(c)] (d) The surcharge and any accrued interest or penalty constitutes a first lien on the real property to which the surcharge applies until paid. An unpaid surcharge will be, until paid, a lien on the qualified property on which it is imposed from the date it becomes payable. The surcharge will accrue interest and penalty and will be treated and collected like all other County property taxes. Any delinquency will be collected through the County Tax Sale process. The provisions of Title 14, Subtitle 8 of the Tax Property Article of the Maryland Code that apply to a tax lien will also apply to the lien created under this law. Any delinquent surcharge collected through the County Tax Sale process must be forwarded to the County designated program manager or, if there is no County designated program manager, to the lender no later than 30 days after the payment was received.
