(1) **DISCUSSION** - [State Legislative Program](#)

Received an update on the 2019 session of the Maryland General Assembly.

Participating in the discussion were Ms. Wenger, Director, Ms. Boucher, Ms. Morningstar and Ms. Samman, Office of Intergovernmental Relations (OIR); and Ms. Mihill, Legislative Attorney.

Mr. Lattner, County Attorney's Office, participated in the discussion on HB413, Public Information Act - Personnel and Investigatory Records - Formal Complaints Against Public Employees. Agreed to support HB413 with amendments to limit the legislation to law enforcement personnel and address unfounded complaints against law enforcement personnel.

Supported, without objection, HB457/SB457, Income Tax Interest and Penalty Waiver Act of 2019.

Supported, without objection, HB320/SB455, 2020 Census Complete Count Commission, and requested that OIR convey to the sponsor the need for the legislation to be fully inclusive of hard-to-count populations, including seniors.

Discussed HB396, Property Tax – Optional Installment Payment Schedule, with Mr. Coveyou, Chief, Treasury Division, Department of Finance. Ms. Navarro noted that Councilmembers will be polled on their position on HB396 after they have had a chance to review the legislation and to have details clarified and questions answered.

Copies of MC/PG112-19, Maryland-National Capital Park and Planning Commission (MNCPPC) – Procurement – Source Selection, were distributed to Councilmembers for review. Councilmembers will be polled on their position on MC/PG112-19.

Distributed detailed summaries of HB1020/SB713, Wireless Facilities – Permitting and Siting; and HB654, Wireless Facilities – Installation and Regulation. Ms. Navarro noted that the issue is complicated and controversial and that it's important that the Council weigh in before the legislation is taken up by the General Assembly. Councilmembers will be polled in the next couple of days on their position.

The meeting adjourned at 1:29 P.M.
