# **GENERAL BUSINESS**

- A. Announcements Agenda and Calendar Changes
- (1) The Council is seeking applicants for the Montgomery County Planning Board. The deadline to apply has been extended to Friday, April 17, 2020, at 5 p.m.

Ms. Singleton, Clerk of the Council, announced that the Council is seeking applicants for the Planning Board; deadline to apply has been extended to Friday, April 17, 2020, at 5:00 P.M. She also announced an addendum to the agenda, correcting the sponsorship of the \$5,000,000 special appropriation for the Economic Development Fund Public Health Emergency Grant Program to the County Council; deleting introduction, public hearing, and action on a resolution to adopt a Board of Health Regulation concerning the use of face coverings and other social distancing measures; adding introduction of **Expedited Bill 23-20**, Contracts - Management and Disposal of Goods - Emergency Procedures; and deleting action on **Expedited Bill 17-20**, Carryout Bay Tax - Suspension.

Councilmembers noted that the resolution concerning the use of face coverings was removed from the agenda because a public health order requiring the use of masks or other face coverings was issued by Dr. Gayles, the County's Health Officer.

No petitions were received this week.

C. Action - Approval of Minutes

#### (6) COUNCIL SITTING AS BOARD OF HEALTH

A. Introduction - Resolution to adopt a Board of Health Regulation concerning the use of face coverings and other social distancing measures Lead Sponsors - Councilmembers Riemer and Albornoz Co-sponsors - Council President Katz and Councilmembers Navarro and Hucker

This item was deleted from the agenda.

#### B. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS); Mr. Hartman, Director, Bethesda-Chevy Chase Regional Services Center; and Ms. Parker, County Executive's Office.

Dr. Gayles updated the Council on the new Health Order that went into effect on April 13, requiring face coverings and other safety measures that offer protection for business employees and customers, noting that he is in contact with the State regarding other spaces that may potentially benefit from similar requirements. A third COVID-19 testing site has opened at the Germantown Vehicle Emissions Inspection Program (VEIP) facility to increase testing capacity within the County; other options for potential testing sites are being explored as well as ways to create access for residents without a primary healthcare provider. The State's chief epidemiologist has completed a map of COVID-19 incidents by zip code, with data broken out by gender and age. Dr. Gayles commented that in the rush to release information, no data on race or ethnicity was included, and steps are being taken to determine causal relationships between housing, race, and infection rates to be able to take steps to address the situation. He noted that there is support from the County's nonprofit agencies in assisting communities of color. He said that some models anticipate the peak number of cases within the next week.

Responding to Mr. Jawando's question concerning the use of reusable shopping bags, Dr. Gayles expressed the view that the risks associated with reusable bags are minimal, and that consumers can bag their own groceries, use self-checkout, and clean their reusable bags at home to minimize potential exposure to the virus.

Mr. Riemer suggested that the Department of Transportation (DOT) consider requiring bus riders to wear face coverings.

Ms. Navarro requested a separate discussion on disparities be scheduled to look into both health and financial issues for communities of color associated with COVID-19.

Dr. Stoddard stated that Montgomery County Fire and Rescue Services (MCFRS) activated Phase 2 of the pandemic surge plan in preparation for the expected surge this week in the number of cases. He commented on the large number of donations of personal protective equipment (PPE) and that an online request form is posted on the County website. Face coverings were provided to County employees. The Food Security Task Force is meeting to address food access issues and the safety of food service providers. The vast majority of calls to 311 are COVID-19-related. Regarding the \$183 million the County is expected to receive from the CARES Act for support for non-budgeted items related to COVID-19, Dr. Stoddard said guidance on use of the funds is expected on April 24.

Responding to questions from Mr. Rice, Dr. Gayles said residents with concerns related to face covering compliance should call 311 and that questions would be forwarded to the Licensing and Regulatory Compliance Team. Regarding the reopening of schools, Dr. Gayles expressed the view that it not realistic for schools to open in the near future even if the number of COVID-19 cases declines, given the need to continue social distancing measures to ensure the number of cases continues to decline.

Ms. Parker provided an update on the work of the COVID-19 Communications Team, stating that press releases are translated into Spanish, and a COVID-19 newsletter (formerly the Paperless Airplane) is emailed to approximately 380,000 residents and is updated twice a week. The COVID-19 communications page is available on the County's website. Mr. Hartman said there is a growing number of community partnerships, and a translation team is providing relevant information in six languages. Ms. Navarro suggested the team look at the MCPS translation unit for ways to enhance service.

The meeting recessed at 12:34 P.M. and reconvened at 1:39 P.M.

Mr. Rice made the motion, which carried unanimously.
