GENERAL BUSINESS

A. **Announcements** - Agenda and Calendar Changes

Ms. Singleton, Clerk of the Council, announced an addendum to the agenda, adding introduction of special appropriations to the County Government's FY21 Operating Budget, for Arts and Humanities Council of Montgomery County Non-Departmental Account (NDA) - \$3,250,000 for Arts COVID-19 Relief Fund; and for the Economic Development Fund - \$14,000,000 for Support for COVID-19 Response Reopen Montgomery; adding Mr. Hucker as a co-sponsor of Subdivision Regulation 20-01 concerning Rules of Interpretation - Computing Time Periods; and correcting **Bill 25-19** to show as expedited.

(3) **PRESENTATION** - Report of the Charter Review Commission (CRC)

Participating in the discussion were Mr. Margolies, Chair, and Mr. Danley, Member, CRC; and Ms. Wellons, Legislative Attorney.

Mr. Margolies presented the 2020 report of the CRC, stating that the structure of the County Council was the only issue studied this year. The CRC majority recommended against changes to the size and composition of the Council.

Mr. Danley presented the minority recommendation that there should be a Charter amendment that would create a Council comprised of nine district seats.

A public hearing on the CRC recommendations is scheduled for July 7, 2020 at 1:30 P.M.

(4) **DISTRICT COUNCIL SESSION**

A. **Introduction** - <u>Subdivision Regulation Amendment 20-01 concerning Rules of Interpretation - Computing Time Periods</u>

Postponed to the afternoon.

B. Worksession - Germantown Plan for the Town Sector Zone

Postponed to the afternoon.

(5) COUNCIL SITTING AS BOARD OF HEALTH

A. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, County Health Officer and Chief, Public Health Services, DHHS; and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles reviewed current cases and positivity rate (6.6%) noting that to date, 7.9% of the County population has been tested. The State is providing test kits directly to nursing homes for residents and staff to be tested on a biweekly basis until no cases remain in those facilities, and the County will continue to provide support. The County is undertaking extensive outreach to

the most impacted communities and working with organizations within those communities, such as churches and non-profits groups, to provide testing. Testing will be available on June 25 at the Takoma Park Recreation Center, and DHHS staff will be onsite to provide linkages to social services. Volunteers with Project Hope will be assisting with mobile testing at nursing facilities and group homes. Site selection for placement of mobile units is being finalized and testing of first responders and County employees is being expanded. More contact tracers are being hired and Dr. Gayles noted that 100% of new cases were traced within 24 hours. The Department is working with the State and Prince George's County to discuss partnering to obtain increased epidemiology support from the Centers for Disease Control (CDC). Dr. Gayles and Dr. Stoddard reviewed the reopening criteria for parks and playgrounds and responded to questions from Councilmembers.

The meeting recessed at 12:05 P.M. and reconvened at 1:37 P.M.

(6) **PUBLIC HEARING/ACTION** - Special appropriation to the County Government's FY20 Operating Budget, COVID-19 Human Services and Community Assistance NDA, Support for COVID-19 Response - \$10,500,000 for Montgomery County Food Security Fund and amendment to FY20 Operating Budget Resolution 19-128, Section G, FY20 Designation of Entities for Non-Competitive Award Status: Greater Washington Community Foundation

The public hearing was conducted, and the record closed.

Unanimously supported Mr. Jawando's motion to reduce funding from \$10.5 to \$10.3 million in the draft resolution, as contained in the staff report, as follows:

The County will enter into a public/private partnership with the Greater Washington Community Foundation to establish the Montgomery County Food Security Fund to support the implementation of the food security strategy. The County will provide seed funding of up to \$\frac{\$300,000}{}\$ [[\$500,000]] to the Community Foundation to initiate the fund. The County will commit \$10,000,000 appropriated through this resolution to implement the COVID-19 Pandemic Food Security Response Strategy with the goal of raising \$5,000,000 in private donations in the Montgomery County Food Security Fund.

Adopted **Resolution 19-506**, as amended, approving the subject special appropriation.

Mr. Jawando made the motion, which carried unanimously.

Ms. Navarro made the motion, which carried unanimously.

(8) **PUBLIC HEARING/ACTION** - Supplemental appropriation to Montgomery College's FY20 Operating Budget - \$1,000,000 for CARES Act Higher Education Emergency Relief Funding

The public hearing was conducted, and the record closed.

Adopted **Resolution 19-508**, approving the subject supplemental appropriation.

Mr. Rice made the motion, which carried unanimously.

(9) **PUBLIC HEARING/ACTION** - Special Appropriation to the FY20 Operating Budget, Montgomery County Public Schools' (MCPS) FY20 Operating Budget - \$123,000 for the Verizon Innovative Learning Program Grant

The public hearing was conducted, and the record closed.

Adopted **Resolution 19-509**, approving the subject special appropriation.

Mr. Rice made the motion, which carried unanimously.

(15) Call of Bills for Final Reading

A. Expedited Bill 25-19, Contracts and Procurement - Local Business Preference Program - Established

Participating in the discussion were Mr. Shetty, Director, Office of Procurement; and Mr. Drummer, Senior Legislative Attorney.

Ms. Navarro, Chair of the Government Operations and Fiscal Policy (GO) Committee, reviewed the purpose of the legislation and the Committee recommendation, as contained in the staff report.

Approved, without objection, Ms. Navarro's amendment to change the effective date from July 1, 2002, to August 1, 2020, to give the Office of Procurement more time to prepare for this change in the procurement procedures.

Enacted draft #3 of **Expedited Bill 25-19**, as amended and contained at the end of these minutes.

The GO Committee made the motion and the bill was enacted by a roll call vote:

(16) **DISCUSSION/PRESENTATION**: Economic Recovery Committees

Participating in the discussion were Ms. Kassiri, Deputy Chief Administrative Officer, Mr. Fletcher, Assistant Chief Administrative Officer, Ms. Benjamin, Director, Special Projects, Office of the County Executive; Dr. Crowel, Director, DHHS; Dr. Stoddard, Director, OEMHS; Mr. Nigam, Director, Department of Housing and Community Affairs (DHCA); and Dr. Pollard, President, Montgomery College.

Dr. Stoddard, as Recovery Manager, updated the Council on recovery efforts related to Racial Equity, Public Health, Economic, and Community Advisory Groups, the Q&A Team, Phase 2 County Reopening, Reconstitution of County Worksites, and Childcare.

Received a briefing and status update on the County's recovery efforts related to COVID-19 from the five mission area recovery teams and their subgroups, including: Government Operations and Services, Economic Revitalization, Health and Human Services, Housing, and Education, as contained in the Recovery Situation Report that is included in the staff report. Noted that the Recovery Situation Report will be updated weekly.

(4) **DISTRICT COUNCIL SESSION**

A. **Introduction** - <u>Subdivision Regulation Amendment (SRA) 20-01 concerning</u>
Rules of Interpretation - Computing Time Periods

Introduced draft #5 of SRA 20-01, sponsored by Councilmember Riemer, and co-sponsored by Councilmembers Friedson, Navarro and Hucker. A public hearing is scheduled for July 28, 2020, at 1:30 P.M.

B. Worksession - Germantown Plan for the Town Sector Zone

Participating in the discussion were Chair Anderson, Montgomery County Planning Board; Ms. Wright, Director, Planning Department, Maryland-National Capital Park and Planning Commission (M-NCPPC); and Ms. Dunn, Senior Legislative Analyst.

Ms. Katz stated that this is a worksession for the Germantown Plan for the Town Sector Zone and that action is scheduled for July 21, 2020.

Mr. Riemer, Chair of the Planning, Housing and Economic Development (PHED) Committee, noted that the purpose of the Plan is to replace the existing Town Sector zoning with current classifications for the Churchill Village community of Germantown.

Ms. Dunn reviewed the methodology for proposed zoning translation and the Committee's recommendation for the proposed change in zoning for properties in the four districts of the Plan area, as contained in the staff report.

Staff noted that an issue has been addressed by the Committee where the proposed zoning was non-conforming and that the properties have been translated to conforming zones, as reflected in the tables in the staff report.

The Plan recommended new zones based on three community goals: maintain the residential core; protect open space and recreation areas; and support neighborhood-serving commercial uses. Councilmembers had no objections to the Committee recommendations and stated that they were impressed with the Plan.

Local Business Preference Program. **11B-92.** Purpose. 4 This Article is intended to bolster the County's economic growth and support the 5 creation and retention of employment opportunities within the County by establishing a ten 6 percent (10%) preference for the award of a County contract to a County-based business. 7 11B-93. Definitions. 8 In this Article, the following words have the meanings indicated. 9 Broker means a person that provides goods or services (other than real estate, 10 investment, or insurance sales) on a pass-through basis as: 11 a supplier of goods who: 12 (a) does not own, operate, or maintain a place of business in which goods 13 (1) of the general character required under the contract are kept in stock in 14 the regular course of business; 15 does not regularly assume physical custody or possession of goods of (2) 16 comparable character to those offered to the County; or 17 (3) exclusively acts as a middleman in the sale of goods to the County; or 18 a supplier of services who does not regularly maintain the capability, capacity, (b) 19 training, experience, and applicable regulatory licensing to directly perform 20 the principal tasks of a contract with the County and must provide the 21 principal tasks through a subcontract with a third party. 22 <u>Director</u> means the <u>Director</u> of the Office of Procurement or the Director's designee. 23 Local Business means a business, other than a broker, that: 24 has its principal place of business in the County; 25 (a) (b) meets criteria established by method 2 regulations; and 26 is certified by the Director as a Local Business under the provisions of this 27 (c) Article. 28
