A. **Announcements** - Agenda and Calendar Changes

Ms. Singleton, Clerk of the Council, announced an addendum to the agenda, postponing the public hearing on **Expedited Bill 34-20**, Police - Disciplinary Procedures - Police Labor Relations - Duty to Bargain - Amendments, until September 22, 2020, at 1:30 P.M.; and adding Councilmembers Rice, Albornoz and Katz as co-sponsors of **Expedited Bill 40-20**, Uniform Trader's License Fee.

Acknowledged receipt of a petition from Montgomery County residents opposing Zoning Text Amendment (ZTA) 20-01, Solar Collection System - AR Zone Standards.

C. **Action** - Approval of Minutes Approved the minutes of May 5, 2020, without objection.

(2) **BRIEFING** - Purple Line

Participating in the discussion were Mr. Quinn, Administrator, and Mr. Pollack, Purple Line Project Director, Maryland Transit Administration (MTA), Maryland Department of Transportation (MDOT); and Mr. Conklin, Director, Montgomery County Department of Transportation (DOT).

Mr. Quinn and Mr. Pollack updated the Council on efforts being taken to keep the Purple Line project moving forward despite the demobilization of the concessionaire, Purple Line Transit Partners (PLTP), including design completion, utility relocation, and wall completion. Administrative staff is being put in place to manage the over 100 contracts included in the project. They indicated that more would be known in 30 days regarding what work would be continuing in the near term, that there is no requirement for a new concessionaire to hire employees from PLTP, and that PLTP has submitted a draft transition plan. Mr. Pollack agreed to be a point of contact for any constituent concerns.

Councilmembers commented on the need for the Governor to state his support for the project and indicate who will pay for this project, and on the importance of communication with impacted communities, particularly concerning pedestrian access and safety.

(4) COUNCIL SITTING AS BOARD OF HEALTH

A. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, County Health Officer and Chief of Public Health Services, Department of Health and Human Services (DHHS); and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles reviewed current information included on the COVID-19 data dashboard, noting the number of new cases has increased slightly, as well as the test positivity rate, which is now at approximately three percent. He noted that the majority of new cases are among those aged 0 to 30, which is different from earlier in the year, with less severity of illness and decreased hospitalizations, and said there is an uptick in rate of transmission. He stated that the County has not yet met the State criteria to reopen schools, that 12 non-public schools have reported cases among teachers and students, and that seven other schools are in quarantine due to reported COVID-like illness.

Testing trailers provided by the CDC are in place at Lakeforest Mall and at the Randolph Road Recreation Department Administration Building. New laboratories are being brought online to process tests, and 250,000 rapid test kits from the State are slated for nursing homes and assisted living facilities. They are working with State partners on contact tracing, and Dr. Gayles noted that large family gatherings have been tied to exposures. A regional vaccine dissemination plan is being developed and hopefully a vaccine will become available early in 2021.

Mr. Albornoz encouraged everyone to get a flu shot. Dr. Gayles said flu symptoms are similar to COVID symptoms. He mentioned that flu shots provide protection, and plans for pop-up flu shot clinics would be provided soon.

Dr. Stoddard said they would work with the faith community to provide additional accommodations for the upcoming holidays. Regarding live performances, guidelines for outdoor performances will be provided later this week, but it will take longer for indoor performances given the need to balance the risk. Regarding Halloween events, Dr. Gayles indicated language would be available in the next week, but he recommended against house-to-house trick-or-treating.

Dr. Stoddard stated that as of September 15, FEMA is no longer covering personal protective equipment (PPEs) for use as a preventative measure (but will continue to cover for first responders), and that the County has procured a significant supply of PPEs should a resurgence of the virus occur. They are working to establish long-term housing sustainability. The department is

working with Department of Recreation and the Board of Elections to address in-person voting safety concerns and is urging residents to vote by mail-in ballots.

Mr. Rice commented that it would be helpful to know which local companies are involved in the development of vaccines for COVID-19, and that people of color should be encouraged to participate in vaccine trials.

The meeting recessed at 11:53 A.M. and reconvened at 1:35 P.M.

Councilmembers spoke to the importance of providing high-quality childcare and early education to allow parents to participate in the workforce, which is critical to the County's economic recovery.

Ms. Navarro made the motion, which carried without objection.

The public hearing was conducted and the record closed.

Adopted **Resolution 19-593**, approving the subject special appropriation.

Mr. Friedson made the motion, which carried without objection.

(16) **OVERVIEW** - 2020-2024 Subdivision Staging Policy (SSP) and proposed changes to Development Impact Taxes and the Recordation Tax

Participating in the discussion were Mr. Anderson, Chair, Montgomery County Planning Board; and Mr. Sartori, Chief, Countywide Planning Division, Planning Department.

Received opening remarks from Mr. Anderson, who stated that the County is not producing enough housing, that every decade fewer housing permits are issued, and that impact fees in Montgomery County are among the highest in the region. Planning staff have developed a way to eliminate moratoria and increase affordable housing in the County for the Council's consideration.

Received from Mr. Sartori an overview of the draft SSP, which is the set of policy tools that administer the Adequate Public Facilities Ordinance (APFO) to serve existing and future development. He noted that school-based moratoria continue to this day and expressed the view that it is ineffective and prohibits the Planning Board from approving new housing developments, which in turn negatively impacts the County's economic development, and doesn't solve school overcrowding. He reviewed the scope of the SSP, recommendations for impact and recordation taxes for various housing types, student generation rates, the inclusion of Vision Zero safety objectives into the transportation review process, the impact of new development versus turnover. Data shows that development in Greenfield areas, such as Clarksburg, generate the most students, and that the Planning Board recommends moratoria only be applied in Greenfield impact areas. An index of all recommendations is included in the draft SSP, which can be accessed online.

Councilmembers expressed appreciation to Planning staff for their hard work in developing the draft SSP, noting that there would be many committee meetings in the coming weeks to discuss in detail the many recommendations.

Ms. Navarro noted that the recommendations fit in with the Economic Development Platform adopted by the Council last year.

Mr. Jawando noted that student generation data raises many questions, and suggested a broader view should be taken when considering the extent to which high-rise buildings and studio and one-bedroom units should be incentivized, since they generate the fewest number of students.

Mr. Katz requested staff to provide information on how counties with no moratoriums on development address school capacity issues.
