COMMENTS by Council President Sidney Katz

Mr. Katz said his tenure this year has been everything nobody expected, expressing thanks to Councilmembers and the County Executive for working together to do so much for residents during the unprecedented challenges associated with the COVID-19 pandemic. Programs and funding were created to provide rental assistance and aid to common ownership communities to help prevent homelessness, grants to small businesses were provided to help them stay afloat during the pandemic, to reopen, and to assist with costs associated with

telework; funding was provided for the manufacturing of personal protective equipment (PPEs) and funding was provided to medical and dental practices to help them be able to remain open. Mr. Katz pointed out that these grants were provided while the Council was able to adopt a same-services budget and avoid layoffs and furloughs of employees. A task force was created to determine how to best help businesses, a local small business preference program was established, and focus continued on efforts to improve racial equity and social justice within the County.

ELECTION OF COUNCIL OFFICERS

Mr. Katz called for nominations for Council President. Ms. Navarro nominated Mr. Hucker for Council President. There were no other nominations.

Unanimously elected Mr. Hucker as the third Council President of the nineteenth Council.

Mr. Hucker called for nominations for Council Vice President. Ms. Navarro nominated Mr. Albornoz for Council Vice President. There were no other nominations.

Unanimously elected Mr. Albornoz as the third Vice President of the nineteenth Council.

Adopted **Resolution 19-661**, naming Mr. Hucker to serve as the third President of the nineteenth Council, and Mr. Albornoz to serve as the third Vice President of the nineteenth Council.

On behalf of the Council, Mr. Hucker presented a commemorative gavel to Mr. Katz in recognition of his service as President of the Council.

COMMENTS by new Council President Tom Hucker

Mr. Hucker expressed thanks to his colleagues, family, and staff for their support. Noting the unprecedented time of pandemic and deep recession in the County, he gave special thanks to the essential workers and front-line responders, residents who stepped up by working overtime to improve our community, volunteering, and wearing masks. He said the Council would work tirelessly to address the simultaneous public health and economic crises facing the County while keeping the "Montgomery County Promise: no matter where you come from, we're glad you're here." The pandemic has forced the Council to face inequities and challenge old assumptions, and has given the County the opportunity to recover and rebuild a more prosperous, more equitable, healthier, and more sustainable future.

(3) COUNCIL SITTING AS BOARD OF HEALTH

A. Annual Meeting with Commission on Health

Ms. de la Torre, Chair, Commission on Health, participated in the discussion.

Noted the Commission's four areas of focus for 2021: school health, modernization of public health data, communicable diseases, and racial equity. Efforts include ways to ensure all school-age children are up-to-date on their vaccines, update their system to provide public outcomes, attention on flu and COVID-19 vaccinations; and identifying and correcting racial disparities in the County.

B. Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, County Health Officer and Chief of Public Health Services, DHHS; and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles expressed concern about what will happen moving forward, noting the increase in COVID cases across all ages, increases in emergency room visits and with five out of six hospital intensive care units in the red zone, and indicating that further restrictions may be needed if hospitals run out of capacity. With authorization of the vaccines anticipated shortly, distribution of the limited supply will begin December 14 to the highest priority groups with all nursing homes signed up for the program. Dr. Gayles indicated infrastructure is being put in place for future distribution of the vaccine. Grant funding was obtained for the purchase of emergency supply kits for distribution in the most highly-impacted communities.

Commenting on enforcement of public safety requirements, Dr. Stoddard noted expanded efforts by the Department of Transportation (DOT), Department of Environmental Protection (DEP), Animal Services, and the Police Department. He said over 100 locations were visited, and credited education efforts for the result of no citations being issued. Education efforts will be continued as enforcement continues to be expended. Discussions are underway regarding programming to promote the vaccine and possible incentives.

Discussing the reopening of schools, Dr. Gayles said the understanding of how children transmit the virus is limited, children are more likely to be asymptomatic, and less likely to be tested and that children tend to congregate when participating in activities such as sports. Dr. Stoddard

said they are less willing to experiment by putting kids in schools, noting the first death of a child under age nine in the State, but that they are aware that families may be struggling with the virtual learning model. Mr. Rice commented that the American Academy of Pediatrics reported that the number of cases in children doubled in July/August, and Dr. Gayles said an understanding of the long-term impacts of COVID is still being developed. Mr. Riemer commented that younger children are less likely to transmit the virus, and Dr. Gayles noted that this was considered in MCPS' plan to bring back the youngest children first in its phased-in approach to school reopening. He stressed the need to reduce overall community transmission rates before schools could safely reopen, and that the availability of a vaccine is a game changer and should make students and staff more comfortable with returning to school facilities. Dr. Stoddard stated as the data shifts, they are willing to modify their recommendations.

Mr. Friedson commented that waiting 7 to 10 days to get test results is too long and asked what can be done to reduce that time. Dr. Gayles said that that situation is not unique to the County as the number of people getting tested has increased. Testing capacity at laboratories is being increased, the State is working to increase staffing, and the County's Call Center staff is also being increased. Mr. Friedson suggested wait times at testing sites be published on the COVID portal, if possible. A listing of all testing sites is updated daily on the COVID portal.

Mr. Albornoz noted that decisions are not made in a vacuum and suggested it might be helpful to publish the information used to reach those decisions. He noted that with children not in school, vaccination levels are at record lows and that it is important to reinforce the need for traditional vaccines.

C. Coronavirus Relief Fund

This item was postponed to the afternoon.

The meeting recessed at 1:02 P.M. and reconvened at 1:48 P.M.

Ms. Navarro, Chair of the Government Operations and Fiscal Policy (GO) Committee, reviewed the Committee recommendations, as contained in the staff report.

Supported, unanimously, Ms. Navarro's motion for the following two amendments.

Add Section (f) after line 14:

- (f) Responsibilities of each department and office. Each Executive and Legislative Branch department and office must:
 - (1) designate an employee to serve as the racial equity and social justice lead for the department or office to coordinate work with the Office;
 - (2) develop a department or office racial equity and social justice action plan in coordination with the Office; and
 - (3) provide <u>discrete data on disproportionality and other</u> information to the Office as needed.

Add the following to line 12 in Section D: <u>including the recommended</u> operating and capital budgets for the County Board of Education to read:

(D) a requirement for the Executive to explain how each management initiative or program that would be funded in the Executive's annual recommended operating and capital budgets, including the recommended operating and capital budgets for the County Board of Education, or in a supplemental appropriation promotes racial equity and social justice;

Enacted draft #4 of **Bill 44-20**, as amended and shown at the end of these minutes.

The GO Committee made the motion and the bill was enacted by a roll call vote:

(3) COUNCIL SITTING AS BOARD OF HEALTH (continued)

C. Coronavirus Relief Fund (CRF)

Participating in the discussion were Mr. Watters, Office of Management and Budget (OMB); Mr. Gottesman, Manager, CountyStat; Dr. Stoddard, and Mr. Madaleno, Chief Administrative Officer.

Received an update from on the status of the County's Federal Emergency Management Administration (FEMA) reimbursement requests, noting that the most recent request for \$31.2 million was submitted on November 25, which included mostly personnel costs for frontline and emergency responders. Dr. Stoddard reported that no response has been received to date regarding the request submitted on October 23, although he expects feedback within the next week or two.

Mr. Friedson noted that earlier in the year, it was estimated that total FEMA requests for reimbursement by the December 30 deadline would total \$120 million. He requested an update be provided on the current anticipated total reimbursement amount.

Mr. Madaleno said that so far, \$66 million pertaining to differential pay costs (for March through August) has been submitted for FEMA reimbursement. Dr. Stoddard noted that differential pay is tied to the CRF, and there is no authority after December 30.

(19) **Briefing -** Community Use of Public Facilities (CUPF)

Participating in the discussion were Ms. Bell-Pearson, Director, and Ms. Vitale, Financial Administrator, CUPF; Ms. Lambert, OMB; and Ms. Yao, Legislative Analyst.

Received an update on the status of the CUPF Enterprise Fund, noting that CUPF does not receive tax dollars to support its operations. CUPF has been losing approximately \$1 million in revenue each month that public facilities have been closed due to the COVID-19 pandemic. Thirty percent of CUPF staff have been temporarily reassigned to other departments, such as the Board of Elections and DHHS. Requested that CUPF follow-up to ensure that departments reimburse

CUPF for staff that were reassigned and if CARES funding will reimburse for reassigned staff.

CUPF managed the administration of reopening in September of childcare in MCPS facilities for school-age children, currently operating in 63 schools. Permitting for field use resumed in May 2020. The Silver Spring Civic Building has been booked for various civic and community uses during the pandemic. Noted that CUPF is working with the Department of General Services to identify other County facilities that could be used for public space to substitute for lost space in MCPS facilities due to social distancing mandates.

Discussed the lapsed Memorandum of Understanding between CUPF and MCPS and whether the formula for utility and custodial reimbursement, based on the previous year's use, needs to be reconsidered when school facilities are closed.

Received a summary of two future scenarios, with some public facilities opening in the fourth quarter of FY21 versus facilities remaining closed, and the projected FY21 fund balance. Several Councilmembers noted that space for childcare and ballfield renovations remain priorities.

Recommended that the Council receive an update on the status of the Enterprise Fund prior to consideration of the FY22 budget. Suggested that CUPF think about its vision for the future and about new models for providing use of public facilities to the community, other than an Enterprise Fund model.

(20) **Briefing - Census**

Participating in the discussion were Ms. Vu, Director, and Mr. Ellis, 2020 Census Manager, Office of Community Partnerships (OCP); and Ms. Chen, Legislative Analyst.

Received an overview of the 2020 County census, noting in particular that the self-response rate was 78%, much higher than national state averages. OCP used a multifaceted education and outreach strategy in partnership with stakeholders from a broad representation of sectors and communities to ensure a fair and accurate count of everyone in the County, with a special focus on undercounted communities.

Outreach involved the 142 Census Complete Count Committee members; 376 multi-lingual volunteer Census Ambassadors; targeted outreach to the top seven languages spoken in the County (English, Spanish, Amharic, Chinese, Korean, French, Vietnamese), including multilingual flyers, media outlets and social media; census partners with 14 nonprofit organizations through the State 2020 Census Grant Program; partnering with over 150 other nonprofit, small business, civic, community, and faith or faith-based organizations to promote or provide

information to communities about the census; hosting over 350 census-related outreach events, information tables, staff trainings, virtual presentations, information sessions, or volunteer orientations since August 2019; and developing and distributing 1,500 lawn signs in multiple languages, with a focus on low-response neighborhoods. Targeted outreach areas included Fairland/Castle Boulevard, Long Branch, Aspen Hill, Montgomery Village, and Wheaton. Outreach efforts targeted undercounted populations such as renters, immigrants, and people of color as well as follow-up with non-responses. Methods of outreach also included bus ads, door hangers, and phone banking.

Councilmembers thanked Ms. Vu, Mr. Ellis and everyone involved in spearheading and assisting in achieving such commendable results with the 2020 census, especially during the pandemic and periods of racial unrest.

Each recommendation of a limited issue task force must be shared with the Council, the Executive, and the Racial Equity and Social Justice Advisory Committee.
