#### **GENERAL BUSINESS**

### A. **Announcements -** Agenda and Calendar Changes

Ms. Singleton, Clerk of the Council, announced an addendum to the agenda, correcting the title for the <u>Discussion with Maryland Department of Health: Vaccine Allocation, Distribution and Equity</u>: State and County Responsibilities for Nursing Homes; <u>and Coordination of COVID-19 Vaccinations for Nursing Homes and DDA Group Homes</u>; noting a time change for the public hearing and correction in the title for a Resolution to approve Executive Order 19-21<u>AM</u>, COVID-19 - Local Order - Amending and Restating Order dated December 15, 2020; and correcting the Executive Order 19-21<u>AM</u> for action as the Board of Health and also as the County Council; noting a time change for action on the Spending Affordability Guidelines for the FY22 Operating Budget; adding Councilmembers Hucker, Navarro, Friedson, Albornoz, Rice and Riemer as cosponsors for the introduction of a Resolution reaffirming Montgomery County's

# (1) B. **Acknowledgement** – <u>Receipt of Petitions</u>

No petitions were received this week.

C. **Action -** Approved the closed session minutes of January 22, 2021, without objection.

### (2) COUNCIL SITTING AS BOARD OF HEALTH

C. **Discussion** - with Maryland Department of Health: Vaccine Allocation,
Distribution, and Equity; State and County Responsibilities for Nursing
Homes; and Coordination of COVID-19 Vaccinations for Nursing Homes
and DDA Group Homes

Participating in the discussion were Dr. Chan, Acting Deputy Secretary for Public Health Services, Dr. Martin, Deputy Director, Office of Minority Health and Health Disparities, and Ms. Shek, Deputy Director, Office of Governmental Affairs, Maryland Department of Health (MDH); Dr Gayles, County Health Officer and Chief of Public Health Services, and Dr. Crowel, Director, Department of Health and Human Services (DHHS).

Dr. Gayles, noting inaccurate information circulating via Twitter concerning the availability of vaccines, stated that the County is distributing 99% of doses received weekly, with new strategies implemented this week to distribute doses. They are working with community partners to identify new sites to "meet people where they are," and would continue to prioritize residents over age 75 to receive the vaccine. Dr. Gayles said the County has multiple locations that could be used as mass vaccination sites, and suggested that doses be set aside at the Six Flags site for Montgomery County residents. He indicated that not

knowing the number of doses the County is scheduled to receive weekly ahead of time makes it difficult to schedule appointments, clinic locations, and staffing.

Councilmembers commented on the need to work collaboratively with the State, to distribute the vaccine equitably and transparently, and for the County to receive a supply of doses based on the County's population. Councilmembers expressed the view that the County has a better understanding of how to reach its most highly impacted communities, and that a more centralized approach to preregistration is needed.

Dr. Chan said the State has ramped up its distribution of the vaccine and now there are over 2,000 sites, 79% of the available vaccine has been used, and that the vaccine is allocated by population to all providers including hospitals and pharmacies. She noted that the retail pharmacy program is expanding and that each chosen pharmacy has agreed to work within an equity framework, and the mass vaccination site at Six Flags in Prince George's county is open to everybody. She said local community sites are available to provide access to the vaccine in harder to reach communities, and pointed out that the State gets notification of its weekly allocation from the federal government about a week in advance. Because the vaccine is a federal resource, State governments are limited to providing guidance on residency requirements. Dr. Chan reviewed the State's response to outbreaks in nursing homes, noting they are working with National Guard teams, technical assistance teams, and congregate living teams to prevent outbreaks and assist with staffing needs.

Dr. Martin said as part of the State's GOVAX campaign, community outreach workgroups and an Equity Task Force were established to ensure cultural outreach and appropriateness, and to develop strategies to address hesitancy issues and provide information. Ms. Navarro requested that Montgomery County have a representative on the State's Equity Task Force.

Ms. Shek said over 22,000 vaccinations per day are being given, that they have asked people who have signed up on multiple wait lists to remove themselves from those lists after they receive an appointment. She pointed out that only four states have a centralized preregistration system, and that private providers prefer to use their own systems.

Mr. Albornoz concluded the discussion by asking the State to provide a mass vaccination site in the County, consolidate the registration system, and ensure that more Montgomery County residents are part of State workgroups.

A. **Public Hearing** - Resolution to approve an Executive Order 19-21AM, COVID-19 Local Order - Amending and Restating Order dated December 15, 2020

The public hearing was held and the record closed.

(2.1) **ACTION** - Board of Health Regulation to adopt an Executive Order 19-21AM, COVID-19 - Local Order - Amending and Restating Order dated December 15, 2020, as the County Council

Mr. Hucker noted that the Council does not have the authority to amend an Executive Order, only to reject or approve it as submitted.

Mr. Jawando and Mr. Rice spoke in opposition to the Executive Order, agreeing with public health officials that indoor dining is an unsafe activity that would encourage transmission of the virus, and that to reopen schools, a top priority, transmission levels must be reduced.

Councilmembers expressing support for the Order acknowledged that the reopening of schools is a priority but there is a need to balance competing interests and that a unified regional strategy is needed to effectively combat transmission of the virus, but noted that residents would determine their own comfort level with respect to participating in indoor activities.

Adopted **Resolution 19-729**, approving the subject Board of Health Regulation as the County Council.

Mr. Katz made the motion and the Resolution was adopted by a roll call vote:

## B. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, Dr. Crowel, and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles stated they speak regularly with MDH and have voiced concerns regarding how doses are allocated and the lack of timely response as to how many doses would be received to allow for set up of local clinics. He noted that multiple possible mass vaccination sites have been presented as options for consideration by the State. Priority distribution of the vaccine is being given to residents over age 75, they are working to show on the website the breakdown of first and second doses given, and they have a strategy to get more doses out into communities highly impacted by the virus. While they are looking to expand support to independent living facilities, the State has reduced the number of doses provided to local health departments. They hope to receive clarity from the State whether more doses would be provided for those facilities. Dr. Gayles said a hearing on the Johnson and Johnson vaccine is scheduled for later this month.

Dr. Stoddard indicated he hopes to have the dashboard go live soon, which would provide information regarding distribution of the vaccine. They are looking at opportunities to provide mobile clinics, transportation to and from clinics, and strategies to reach housebound individuals. He noted that public safety personnel are receiving their second doses and would be available to help at other sites. Dr. Crowel commented that highly impacted areas have been identified to help target distribution of the vaccine in those areas.

Mr. Riemer suggested the preregistration form be made easy to understand and to translate it into other languages. He inquired about the surveillance of virus variants and trends. Dr. Gayles said there is limited capacity to sequence every sample and potentially some cases of the variant strain are missed. Dr. Stoddard added that it is likely variants would take over in the United States in six to eight weeks, stressing the importance of the vaccine to mitigate spread.

Dr. Gayles noted that they would continue to provide 100 doses weekly to childcare providers indefinitely, as the State has not provided information on plans to expand distribution, noting that childcare workers are in the 1C category. Public and non-public schools have been asked to devise a prioritization schedule for distribution of the vaccine to staff. Dr. Stoddard estimated that of 9,000 Montgomery County Public School (MCPS) employees, 7,500 will be vaccinated by March 15, either through the County or independently.

Mr. Katz asked that it be made clear on the website that second doses are not being cancelled. Dr. Stoddard said they make sure doses are available before scheduling appointments for people to receive their second dose.

Regarding inclement weather, Dr. Stoddard said it is not a reason to delay distribution. Mr. Rice requested the Council be kept informed of how many appointments are delayed when a site is closed due to weather concerns. Dr. Crowel added that they want to regionalize distribution so older residents don't have to travel too far to receive the vaccine.

The meeting recessed at 12:56 P.M. and reconvened at 1:33 P.M.
