GENERAL BUSINESS

A. **Announcements** - Agenda and Calendar Changes

Ms. Singleton, Clerk of the Council, announced an addendum to the agenda, adding introduction of a special appropriation to the County Government's FY21 Operating Budget, Montgomery County Economic Development Corporation (MCEDC) Non-Departmental Account (NDA), Support for COVID-19 Response - Restaurant Relief Program, \$3,826,998; and amendment to the FY21 Operating Budget Resolution 19-472, Section G, Designation of Entities for Non-Competitive Contract

No petitions were received this week.

C. Action – Approval of Minutes

Approved the minutes of February 11, 12, and 23, 2021, and the closed session minutes of April 20, 2021, without objection. Mr. Jawando was temporarily absent.

(2) COUNCIL SITTING AS BOARD OF HEALTH

A. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, County Health Officer and Chief of Public Health Services, Dr. Bridgers, Deputy County Health Officer, Department of Health and Human Services (DHHS); and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles reported that transmission levels of the virus continue to drop as the number of residents vaccinated increases. Currently, 56% of eligible residents have received at least one dose, with 43% fully vaccinated. The Pfizer vaccine has been approved by the FDA for use in 12- to 15-year-olds and approval by the CDC is expected shortly. The Department is working with Montgomery County Public Schools (MCPS) and non-public schools regarding dissemination of the vaccine, including evening clinics. Focus is also on those individuals aged 21 to 35, and they are working with Federal Emergency Management Agency (FEMA) strike teams to provide additional support to those areas most impacted by the virus. Dr. Gayles also noted they are continuing outreach to homebound individuals and their caretakes to provide the vaccine.

Dr. Stoddard reported that they have gotten through the entire preregistration list, except for those people who are not County or State residents. Currently, approximately 250,000 of eligible County residents have not receive the vaccine. He noted targeted outreach efforts in areas with low vaccination rates, and that the CDC continues to recommend the wearing of face coverings indoors, especially in large gatherings. libraries will reopen on June 1, and senior centers, unless being used for other purposes, will also begin to reopen. The Department is currently reviewing Treasury Department guidance for the use of American Rescue Plan Act (ARPA) funds, which will be distributed in two tranches - one this May and one in May 2022.

Dr. Bridgers commented on efforts to contact and vaccinate the homebound, the homeless, and those in correctional facilities.

Regarding the expected opening of schools at full capacity in the fall, Dr. Gayles indicated federal guidance regarding social distancing is expected and they are working to get children back in schools safely and to minimize transmission of the virus.

Mr. Friedson suggested the County's website be updated to reflect current data and how this information impacts residents' lives.

Mr. Jawando, noting that the communities in the East County have higher levels of unvaccinated residents, requested information on strategies to increase the vaccination rate in those areas and what community factors are being taken into consideration.

(6) **DISTRICT COUNCIL SESSION**

A. **Action -** Zoning Text Amendment (ZTA) 20-08, concerning: Residential Care Facility: Continuing Care Retirement Community

Mr. Reimer, Chair of the Planning, Housing and Economic Development (PHED) Committee reviewed the purpose of ZTA 20-08. Ms. Ndou, Senior Legislative Analyst, reviewed the Committee recommendations, as contained in the staff report.

Enacted **Ordinance 19-16**, approving ZTA 20-08. The PHED Committee made the motion and the Ordinance was enacted by a roll call vote:

(6.5) **UPDATE** - <u>Budget Status</u>

Participating in the discussion were Ms. Michaelson, Council Executive Director, and Mr. Howard, Deputy Director.

Now that the Committees have completed their review of the FY22 operating budget, Ms. Michaelson and Mr. Howard provided a status review on Committees' recommendations on the operating budget, which identified reductions and additions to the Executive's recommended FY22 budget, as contained in the staff report. Additions were put in Category 1 to be considered for ARPA funding during FY22; or Category 2 to be considered for funding after the adoption of the FY22 budget either when more information is available or when the revenue picture becomes clearer; or Category 3 of critical expenditures that should be added to the budget before adoption of the budget tentatively on May 27. Noted that the Category 3 additions plus County Executive budget amendments that were recommended by the Committees are \$758,157 more than the reductions, requiring the full Council to limit the additions or identify offsetting reductions to ensure that the budget is in balance. The Committees identified a total of \$8.5 million in reductions, made \$8.6 million in Category 3 additions, and added \$660,000 from County Executive amendments.

Discussed FEMA and ARPA funding. Ms. Michaelson noted that as additional information is received that affects the operating budget, the Council will be updated.

WORKSESSION - FY22 Operating Budget and FY21-26 Capital Improvements Program (CIP) Amendments

(7) **CIP**: Libraries

Mr. Jawando, Lead for Libraries on the Education and Culture (E&C) Committee, reviewed the Committee recommendations for libraries, as contained in the staff report.

Ms. Chen, Legislative Analyst, provided an update on the Noyes Library for Young Children.

Councilmembers noted the importance to the community of reopening libraries, which are used for so much more than just borrowing books, as soon as possible.

Supported, unanimously, the E&C Committee recommended FY21-26 CIP amendments for Libraries.

Mr. Rice, Chair of the E&C Committee, reviewed the Committee recommendation for the Public Arts Trust, as contained in the staff report.

Supported, unanimously, the E&C Committee recommended FY21-26 CIP amendment for the Public Arts Trust, as recommended by the County Executive.

(9) **CIP**: Cost Sharing: Montgomery County Government (MCG)

Mr. Rice, Chair of the E&C Committee, reviewed the Committee recommendations for Cost Sharing: MCG, as contained in the staff report.

Supported, unanimously, the E&C Committee recommended FY21-26 CIP amendments for Cost Sharing: MCG.

(10) <u>Community Grants NDA</u>

Mr. Rice, Chair of the E&C Committee, reviewed the Committee recommendations for Community Grants, as contained in the staff report.

Mr. Friedson stated that he serves of the Board of Bethesda Green and would abstain from voting on the grant for Bethesda Green.

Mr. Rice made a motion, which carried 8 to 0 with Mr. Friedson abstaining, in support of the grant for Bethesda Green.

Mr. Jawando made a motion, which carried without objection, in support of the FY22 Community Grants NDA, as recommended by the County Executive.
