GENERAL BUSINESS

A. Announcements - Agenda and Calendar Changes

Ms. Singleton, Clerk of the Council, announced an addendum to the agenda, noting that there are no minutes for approval this week; adding introduction of a special appropriation to the County Government's FY21 Operating Budget, Department of Health and Human Services (DHHS), \$250,000 for Asian American Health Initiative COVID Response;

(1) B. Acknowledgement – Receipt of Petitions

Acknowledged receipt of a petition from residents of Montgomery County opposing the County Executive's proposed \$64.7 million property tax hike.

(2) COUNCIL SITTING AS BOARD OF HEALTH

A. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Gayles, County Health Officer and Chief of Public Health Services, and Dr. Bridgers, Deputy Health Officer, DHHS; and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Gayles provided an update on COVID-related statistics, noting that transmission levels are in the "good" range, and that over 60% of residents have received at least one dose of vaccine, with 50% fully vaccinated. Vaccination of 12- to 15-year olds began last Thursday and they are partnering with MCPS to provide vaccine opportunities. He noted that children must have parental consent in order to receive the vaccine and they expect to get a large number of ages 12 to 15 to get vaccinated in coming weeks. The race/ethnicity gap in dissemination of the vaccine is shrinking, the State has encouraged private providers to register on Immunet to have doses shipped directly to them, and new community partners are being brought in to target communities with lower vaccination rates to expand vaccination opportunities.

Dr. Gayles said their role is to provide guidance on how to move forward and keep families safe and recommended residents still continue to wear face coverings, noting that 40%, or approximately 400,000 residents, have not received the vaccine, stressing the importance of getting the vaccine to drive transmission rates down even further. The State requires the wearing of face coverings, regardless of vaccination status in certain situations, including in healthcare facilities and school settings. The Center for Disease Control (CDC) guidance applies to those people fully vaccinated as they are not likely to transmit the virus, but there is no

enforcement mechanism. Businesses can establish policy for their space to keep employees and customers safe.

Dr. Stoddard said they are working with an external behavioral health specialist regarding appropriate messaging for various populations to encourage getting the vaccine. He encouraged residents to practice kindness and be respectful of people's choices of whether to wear face coverings even if fully vaccinated. He stated all County front-line employees have been offered multiple opportunities to receive the vaccine and 71% of law enforcement and 75% of fire fighters have been vaccinated. Some employees are refusing to get the vaccine, but this is not a reason to not come to work. About 12% of population is under age 12 and not eligible for the vaccine and are required to wear face coverings.

Dr. Bridgers discussed the vaccination program for homebound residents, noting that of 1,300 people registered, approximately two-thirds have been vaccinated, including their caregivers. Noted that 397 homebound and their caregivers remain to be vaccinated. Clinical staff will be diverted to participate in strike teams to ramp up vaccination of homebound residents.

B. <u>Introduced a resolution to adopt a Sixth Amended Board of Health</u>
Regulation to prevent the spread of COVID-19 in the County

Senior Legislative Attorney Drummer explained that this resolution would incorporate changes from the first and second phases for reopening the County based on the percentage of the County population receiving COVID-19 vaccinations and modify the face covering requirements based on recent CDC and State Department of Health guidance. The Board of Health regulation would be automatically rescinded on May 28, 2021, when more than 50% of the County population would be fully vaccinated.

The public hearing was held and the record closed.

C. Action - Resolution to adopt a Sixth Amended Board of Health Regulation to prevent the spread of COVID-19 in the County

Approved, unanimously, Mr. Friedson's motion to amend the Board of Health regulation to clarify that all organized sports played in the County must comply with the gathering guidelines described in paragraph 5 of the regulation and with the face covering requirements in paragraph 2; clarify that fitness centers must follow gathering limits in paragraph 5 and face covering requirements in paragraph 2; to remove the requirement for food

service establishments to maintain a daily record of date, time, name and contact information for at least one person for each dining party to assist with contact tracing; and to update the numbers in the background information to reflect that more than 60% of the County population has received at least one dose of the vaccine and that the virus thus far has claimed the lives of 1,490 County residents.

Adopted Resolution **19-842**, approving the Sixth Amended Board of Health Regulation to prevent the spread of COVID-19 in the County, as amended.

(9.5) **Presentation** by Planning Staff on Countywide Demographic Changes

Participating in the discussion were Ms. Wright, Director, Ms. McCarthy, Ms. Blackford, Mr. Holdzkom, and Ms. Stern, Montgomery Planning Department.

Ms. Navarro, who requested the presentation, stated that the County has changed dramatically over the last 30-35 years and budget decisions for services and the delivery of services to residents need to reflect current demographics.

Received a presentation by Montgomery Planning Department staff on countywide demographic trends, covering population growth and growth rates, components of growth, and social characteristics of population over time; density - 8 - 5/18/2021

of population and population social characteristics by place; and predominance of race by place over time. Census tracts show that the over 65 population is up and rising; the under 5 population is falling, as are birth rates; and the younger population is more diverse. On race/ethnicity, data shows increasing diversity but geographic segregation along racial lines, and income/race are correlated and share a geographic pattern. The geographic distribution data shows the upcounty is whiter and less densely populated; the downcounty, eastern county, and along the I-270 corridor are less racially predominant than the rest of the County; and more tracts are becoming more racially diverse and having person-of-color majorities.

Discussed how demographic information is influencing planning trends in the County for housing, public facilities and amenities, parks and public space, and how it will tie into Thrive Montgomery 2050 goals around equitable communities with access to attainable housing, healthy foods, employment, transportation, education, as well as economic health and environmental resilience.

Mr. Jawando requested information on the seven lowest income tracts and how they have shifted going back to 1990, and where the two census tracts are located that are 95% of one race/ethnicity.
