### (1) B. **Acknowledgement -** <u>Receipt of Petitions</u>

No petitions were received this week.

C. **Action -** Approved the minutes of March 2, 4, 8, 9, 11, and 12, 2021, without objection.

#### (2) COUNCIL SITTING AS BOARD OF HEALTH

A. Update - Novel Coronavirus (COVID-19) and County Public Health Planning

Participating in the discussion were Dr. Bridgers, Deputy Public Health Officer, Department of Health and Human Services (DHHS); and Dr. Stoddard, Director, Office of Emergency Management and Homeland Security (OEMHS).

Dr. Bridgers reviewed current COVID-related statistics, noting the very low rate of transmission in the County, which has one of the lowest case rates in the State. By the Centers for Disease Control and Prevention's (CDC) estimate, 63% of the County's eligible population has been fully vaccinated, and the demand for the vaccine is decreasing. School-based vaccination opportunities are being planned and the Department is looking at ways to address hesitancy issues.

Dr. Stoddard reported that the mass vaccination site at Montgomery College currently remains open and its status will be reevaluated on June 19. He anticipates that both the Pfizer and Moderna vaccines will receive FDA approval in early fall for dissemination to children ages 5 to 11. OEMHS is focusing on the ramp-up of recovery efforts as libraries, recreation, and senior centers begin to reopen. He noted the focus on getting the vaccine to younger and Black and African American and other highly impacted communities, noting that the gap has lessened for Latinos. A town hall meeting on the economic impact of COVID on women in the workplace was held and an after-action report featuring lessons learned regarding the County's response to COVID-19 will be completed for future reference.

Mr. Hucker requested data on dissemination of the vaccine by race/ ethnicity for children aged 12 to 18 and plans for clinics to be held at MCPS locations over the summer.

Mr. Albornoz requested more detailed data on vaccination efforts and hesitancy issues in the County's minority communities in order to better serve them.

Ms. Navarro requested a robust briefing on recovery strategies be scheduled for a future Council meeting.

Mr. Jawando suggested a joint HHS/Planning Housing and Economic Development (PHED) Committee meeting be held to discuss the Office of Legislative Oversight's report on the impact of the pandemic on women.

#### C. Action - Ashton Village Center Sector Plan Resolution

Mr. Riemer, Chair of the PHED Committee, provided a summary of what is before the Council today for action. The Plan takes into account concerns raised by the community and strives to maintain the rural look and feel of the community, while recognizing the need for more housing and amenities.

Ms. Dunn, Senior Legislative Analyst, reviewed the decisions from the Council's May 4, 2021, worksession, as contained in the resolution in the staff report.

Adopted **Resolution 19-904**, approving the Ashton Village Center Sector Plan. Mr. Riemer made the motion, which carried unanimously.

# D. **Overview -** <u>Presentation by the Planning Board - Overview of Thrive</u> Montgomery 2050

Participating in the discussion were Chair Anderson, Montgomery County Planning Board; Ms. Wright, Director, Planning Department, Maryland-National Capital Park and Planning Commission (M-NCPPC).

Received an update on Thrive Montgomery 2050, a framework to guide planning for land use, housing, the economy, equity, transportation, parks and open space, the environment, historic resources, urban design, and the arts and culture over the next 30 years. These recommendations are intended to guide future master plans, County and State capital improvement processes, and other public and private initiatives that influence land use and planning in Montgomery County. Noted that with 85 percent of the land already developed or otherwise constrained, accommodating growth in the County will be a challenge.

Ms. Wright stated that they have been working on Thrive Montgomery for 3 years, noted that a lot of successful outreach was done, commented on changes to the County's demographic characteristics since the General Plan Refinement of the Goals and Objectives was completed in 1993, and stated

that the objectives of the plan are to achieve economic health, equitable communities and environmental resilience.

Councilmembers provided comments on the need to be innovative and strategic as the Council reviews this generational undertaking, expressed a desire to not rush the process and to get input from as many people as possible, possibly going back to an earlier version of plan in which issues such as the "missing middle" were covered more in depth.

Noted that the Council will hold public hearings on June 17 and 29, 2021, and that the PHED Committee will begin taking up the plan in July. It was noted that the Council should be reaching out to all communities for their input and participation.
