COMMENTS by Council President Tom Hucker

Mr. Hucker expressed thanks to his family, colleagues, and staff for their support and hard work during the challenging year and for their dedication to making the County a fair, just, and welcoming place. A video entitled "A Year of Recovery" was presented, highlighting the Council's efforts in the past year to make the County stronger, healthier, more prosperous, and more equitable than in the previous 12 months; noting honors received from Rebuilding Together for commitment to regional housing goals, and from the NAACP for efforts to advance racial equity and social justice and for police reform; and included thanks from Dr. Fauci for the County's efforts in response to the pandemic. Acting as

the Board of Health, the Council issued regulations to keep residents safe, fought to obtain a fair share of the vaccination when it became available, opened a mass vaccination site, and strived to reach underserved communities, resulting in obtaining the highest vaccination rate in the country.

The video highlighted efforts by Councilmembers to maintain the County's Triple-A bond rating, support businesses and families, spur investment in communities, get kids back to school safely and address learning loss, achieve housing goals, push to reopen libraries, prevent eviction of families from their homes, help small businesses, improve public safety, protect the most vulnerable residents, improve pedestrian safety, and invest in transportation infrastructure. He noted that the \$6 billion budget adopted by the Council created a roadmap for the County's recovery and revitalization, while fully funding Montgomery County Public Schools (MCPS) and Montgomery College without raising taxes, prevented proposed delays in construction of Woodward and Northwood High Schools, and kept the purple line tunnel construction on schedule. Mr. Hucker noted his organization of a statewide coalition to call on Governor Hogan to release a statewide stimulus package for residents and small businesses, and his efforts to promote smart, sustainable projects including the Purple Line, the Corridor Cities Transitway (CCT) expansion of the Red Line, expansion of bus rapid transit system, and in the opening of an early voting site in White Oak to ensure all residents have the same ease of access to cast a ballot.

ELECTION OF COUNCIL OFFICERS

Mr. Hucker called for nominations for Council President. Ms. Navarro nominated Mr. Albornoz for Council President. There were no other nominations.

Unanimously elected Mr. Albornoz as the fourth Council President of the nineteenth Council.

Mr. Albornoz called for nominations for Council Vice President. Mr. Riemer nominated Mr. Glass for Council Vice President. There were no other nominations.

Unanimously elected Mr. Glass as the fourth Vice President of the nineteenth Council.

COMMENTS by new Council President Gabe Albornoz

Mr. Albornoz expressed thanks to his colleagues, family, and staff for their support. He noted recent challenges faced by the County, including addressing the fallout of the longest federal government shutdown in history; navigating the greatest test to public health and the social safety net in a century; living through the most consequential awakenings on the subject of racial equity since the civil

rights movement; and confronting the toxic aftershocks of the most contentious presidential election in modern times. He said by partnering with the Executive Branch and private and non-profit sectors, the County achieved the highest vaccination rate in the country, prevented 7,000 evictions, and passed legislation to address racial inequities, promote economic stability, and address climate changes facing our environments.

Current challenges include the circulation of another variant of the COVID virus, increased crime, the deep impact of the pandemic on the local economy; the exhaustion of first responders, teachers, social workers and others because of the pandemic, and the need to address mental health issues faced by residents young and old. Mr. Albornoz stated that the County's fiscal health is better than predicted at the start of the pandemic, but the issues of inflation, unemployment, and the recovery of the small business sector must be addressed; the County must be prudent with future spending and consider both long and short-term consequences, and a holistic and sustainable approach to fully recover from the pandemic and address long-standing inequities.

Mr. Albornoz stated that in the coming year, he plans to pursue policy initiatives to close the gap on health disparities in our community, as the pandemic shone a spotlight on communities where inequities already existed; pursue the ability to share data among providers so holistic care can be provided; fight to end childhood hunger in the next three years; and expand tele-health and tele-medicine opportunities and increase mobile care capacity. In conclusion, he stated the resolve of the Council would move the County forward to ensure the County is one of the best places to live, work, worship and raise a family.

Mr. Albornoz announced that the Legislative Session would be moved to the end of today's meeting.

(18) COUNCIL SITING AS BOARD OF HEALTH

A. <u>Updates</u> from County Government and Montgomery County Public Schools (MCPS) - Novel Coronavirus (COVID-19) and Health Planning

Participating in the discussion were Dr. Crowel, Director, Mr. O'Donnell, Program Administrator, Public Health Emergency Preparedness and Response, Department of Health and Human Services (DHHS); Dr. Stoddard, Assistant Chief Administrative Officer; Mr. D'Andrea, Chief of Staff, Office of the Superintendent, and Ms. Iszard, Coordinator, Student Health and Wellness, MCPS.

Received an update from DHHS on current County-wide COVID-19 data and compared it with December 2020 data and changes from November to December 2021; omicron variant information, and holiday travel recommendations.

Mr. O'Donnell shared that the County received additional pediatric doses from State this week. As expected, vaccination rates are increasing in the 5 to 11-year age range as more doses have been received and there has been more equity-focused outreach to increase vaccination rates. MCPS is holding vaccine clinics in the East County and Germantown areas to increase vaccine accessibility, as well as Title I and Latinx populations.

Presented data on pediatric case trends, data trends based on geographic locations, breakthrough and unvaccinated case trends, school case trends, hospitalization rate trends, testing data trends, flu vaccine rates, County and MCPS vaccine site locations, status update on moving the clinic at Lakeforest Mall indoors, and availability and distribution of rapid test kits. Dr. Stoddard also shared an update on County employee testing and vaccination rate progress.

Mr. D'Andrea presented an update on MCPS Staff vaccination requirement, testing programs, Medical Officer search, updated quarantine guidance and positive case and quarantine data prior to November 25, 2021.

Mr. Albornoz requested that links to guidance on travel and in-person events recommendations be included on County websites.

In response to Mr. Albornoz's questions, Mr. O'Donnell shared operational changes enacted to avoid future dosing errors, such as the incident that occurred at the South Lake Elementary School vaccine clinic.

Mr. D'Andrea indicated that MCPS will share messaging on the importance of

testing, especially before winter break. In response to the concern shared by Mr. Rice surrounding a recent Covid outbreak among a high school athletic team, Mr. D'Andrea shared that MCPS is working in partnership with DHHS to investigate and analyze the data and information to avoid similar situations.

Mr. Hucker requested information on publicizing vaccine clinics in Title I Schools. Ms. Iszard shared that links for vaccine appointments are first sent to Principals of Title I schools, then to families of students in Title I schools, and then the general public. This targeted communication will help ensure priority access to students of these schools. Mr. Hucker pointed out a gap in communications from MCPS regarding vaccine distribution for the general population and requested follow up information regarding this.

Mr. D'Andrea stated that MCPS is not currently considering an end to a mask mandate given the positivity rate, but if the mandate should change, it would be done in collaboration with DHHS.

Mr. Friedson requested data regarding the fully vaccinated pediatric age range and if the current data includes the two doses and includes the three-week waiting period or not. Dr. Crowel will follow up with more information.

Mr. Riemer requested the MCPS policy on escalating disciplinary action for staff who are non-compliant with the vaccine mandate.

Mr. Glass requested an update on hiring process for a Chief Health Officer.\; noted the response from Mr. D'Andrea that candidates are currently being vetted by the State.

(4) Call of Bills for Final Reading:

A. Expedited Bill 41-21, Elections - Council Districts - Boundaries; Addendum to Staff Report

Participating in the discussion were Ms. McCartney-Green, Legislative Attorney; Ms. Dunn, Senior Legislative Analyst; and Mr. Zyontz, Council Senior Fellow.

Before the Council today was the revised Redistricting Commission's map which includes changes from the Council's discussion on November 30, 2021. Ms. Dunn reviewed the proposed changes to the map as shown on pages 3 to 8 of the staff report, which include the neighborhoods of Kemp Mill, Northwest

Park/Oakview and Hillandale, Willows of Potomac/Traville Gardens, Aurora Hills, Potomac/North Bethesda, and Ken-Gar. Noted that the change to the Kemp Mill district would slightly reduce but still retain the plurality of the Hispanic community in that district. Further refinements to the Commission's map were included in the addendum staff report dated December 6, 2021, which reflect changes to the Derwood/Redland area. The Council acknowledged the finding that changes to the Four Corners area could not be achieved in conjunction with the proposed changes to the Derwood/Redland community.

Councilmembers thanked the Redistricting Commission and Council staff for their extraordinary work to create seven districts to reflect the County's communities, acknowledging the difficult tradeoffs that had to be made during the collaborative process.

Mr. Friedson suggested the Council postpone action to allow for more time for community input on the new proposed changes to the Redistricting Commission's map. He indicated he was disappointed in certain aspects of the proposed redistricting but acknowledged the associated challenges. Mr. Albornoz declined to postpone action on the Expedited Bill.

Enacted draft #2 of **Expedited Bill 41-21**, as amended and shown at the end of these minutes.

Ms. Navarro made the motion and the expedited bill was enacted by a roll call vote:

Sec. 1. Section 16-2 is repealed and amended as follows:

16-2. Boundaries of Council districts.

The boundaries of the [5] 7 Council districts required under Section 103 of the County Charter are [as follows] shown on a Geographic Information Systems (GIS) map located on the Council's website and identified as the 2021 Approved Council District Map.

Sec. 2. Expedited Effective Date.

The Council declares the district boundaries are for the purpose of regulating Council election conducted after December 31, 2021. This Act takes effect on the date on which it becomes law.
