

Montgomery County Councilmembers,

The pandemic developed from numerous governmental missteps. I urge the Council to think prudently before diluting the civil rights of the residents of Montgomery County. The decisions made by the Council should not usurp the U.S. Constitution nor should they violate the GINA Act through genetic discrimination. The following information is submitted:

- The PCR test used to determine infection was operating under Emergency Use Authorization (EUA). The **CDC withdrew it's request for continued use** on December 31, 2021. (1)
- Recently released DARPA documents show that Ivermectin and HCQ acted as **a curative throughout all phases of illness**. The denial of this treatment has cost many lives. (2)
- On December 2, 2020 the **NIH published a study** showing Ivermectin was found to inhibit severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2). (3)
- **The CDC verified deaths** in VAERS due to the COVID-19 vaccine was 0.0022% for 520 million doses administered in the United States (Dec. 14, 2020 thru Jan. 10, 2022) — **that's 11,225 human deaths**. (4)  
On **vaers.hhs.gov** - "Underreporting" is one of the main limitations of passive surveillance systems. (4a)  
It is widely recognized that VAERS reporting contains only 1 – 10% of vaccine adverse events.
- The vaccine is not stopping people from getting or transmitting the virus — *"CDC Director Rochelle Walensky said that **Covid-19 vaccines are no longer effective at preventing transmission of the virus.**"* (5)
- As per Governor Hogan Montgomery County will receive doses of Remdesivir. Has the Governor ignored the NIH publications of *"Preclinical Assumptions Overestimate the Clinical Efficacy of Remdesivir"* (6) or *"Remdesivir and Acute Renal Failure"*? (6a)

What is this pandemic based on? The Council should demand proof of isolation of the SARS-CoV-2 virus — the attached MPIA to the Maryland Department of Health indicates it does not exist. What is the purpose of vaccine identification i.e., the passport? Control? Segregation? Depopulation? Maybe the residents of Montgomery County should draft a referendum for the next ballot to limit the mobility of elected officials. The people hold the power and this passport will not stand. It is genetic discrimination and the Council does not hold conservatorship over the people.

The Maryland Department of Health (MDH) received your August 22, 2021 request under the Public Information Act, Md. Code Ann., Gen. Prov. ("GP") §§ 4-101- 4-601, seeking the following records and information:

*"(A) information that describes the isolation of the SARS-CoV-2 (COVID-19) virus sample that was obtained directly from a deceased patient and  
(B) where patient samples were not combined with any other genetic material and  
(C) studies, reports, or guidance of the aforementioned information (A & B) provided by the Centers for Disease Control and Prevention (CDC), National Institute of Health (NIH), and the National Institute of Allergy and Infectious Diseases (NIAID)."*

The Maryland Department of Health has no records related to this request.

Pursuant to GP §4-203(c)(1)(i)(4), I must inform you of all remedies available for your review. You may seek direct judicial review pursuant to GP §4-362. You may also file a complaint with the Public Information Act Compliance Board concerning the amount of the fee charged (if applicable) if it exceeds \$350.00, see GP §4-1A-01 et seq. Pursuant to GP §4-1B-01 et seq. you may refer any concerns about this decision to the Public Access Ombudsman at [pia.ombuds@oag.state.md.us](mailto:pia.ombuds@oag.state.md.us) or 410-576-6560.
