Subject: Proposed proof of vaccination requirement for certain establishments

A few concerning points:

There has not been adequate outreach to the small business community regarding this proposal of vaccination requirement. This requirement will have nothing but negative and deleterious effects. Segregation, inept manpower to enforce these measures, and business closures.

-->There is immense opposition to this measure even whilst they are trying to be brought in the back door. Raise public awareness that you all are trying to implement these measures, you will have A LOT more opposition!

-->Nothing positive will come of this.

MoCo has an extremely high vaccination rate already, however plenty of those vaccinated were infected recently and continued to spread disease. As of 1/24/22 83.5% are fully vaccinated and almost 50% boosted according to:

-->There is not one licensed medical product on this planet that is safe for everyone. **Not one.**
