

Dear Montgomery County Executive Elrich and Councilmembers Albornaz, Navarro, Glass, Hucker, Katz, Jawando, Navarro, Rice, and Riemer:

As a proud *resident* of Montgomery County for over 3 decades and a *small business owner* in Bethesda of over 12 years, I am horrified by recent legislation introduced by Councilmember Albornaz to implement Vaccine Passports (I will abbreviate as "Vaxports"). As someone who has mostly supported liberal politics, I am completely disheartened to see our progressive county devolve into dispensing ineffective draconian measures and enthusiastically pushing discriminatory policies. To stop this backsliding towards totalitarianism and restore our democracy, VOTE NO to Vaxports because they are completely scientifically and logically baseless as I will detail below.

It must be noted that *true vaccines* are supposed to be for the *benefit of the injected*. Going forward, I will refer to the Covid "Vaccine" (Pfizer/BioNTect, Moderna, Johnson & Johnson/Janssen, AstraZeneca/Oxford) as an Experimental Injection because it is NOT an actual vaccine since it does NOT stop transmission and does NOT stop infection of the virus.

Here are the 3 basic premises for Vaxports as well as corresponding refutations:

(1) *"There exists a seriously deadly pandemic defined by accurate diagnostic testing."*

*The infection fatality rate of Covid for the vast majority of the healthy population is comparable to that of Influenza (in the case of children, Influenza is more lethal!), which does NOT make this a true pandemic like that of the 1918 Spanish Flu.

The PCR/lateral flow/nasal swab, the most commonly used form of diagnostic testing, is a [complete misuse of the device as well as being a completely fraudulent method of diagnostic testing made up by Christian Drosten](#). As anyone with middle school education from MCPS would know, proper scientific method (particularly for diagnostic testing) requires a clear positive control and negative controls. The PCR "test" neither has a proper positive control (isolated and purified form of the virus taken from a human that is completely gene sequenced) nor negative controls (no comparison done to rule out false positives being triggered from the common cold virus, other coronaviruses, influenza, etc.). The vast majority of positives have been "False Positives," triggering a Test-demic. Consequently, PCR-as-a-diagnostic was determined to be fraudulent in numerous Western European Courts, including in [Portugal](#) and [Austria](#). Furthermore, the same lack of proper controls is present in the Antibody/Antigen test, which is further made inherently unreliable because antibodies naturally dissipate in the body following the period of infection/immune response. Recently, **CDC Director Walensky admitted on "Good Morning America" that **"These tests are not authorized to determine Contagiousness."**

(2) *Since there were no successful early treatment methods, Emergency Use Authorization of the Experimental Shot became the only method of treating victims of the SARS-2 virus.*

*[Early on during the lockdowns, Highly-Effective \(85%+\) Early Treatment methods](#) were developed using inexpensive combinations of vitamins, minerals, and post-patent drugs safely time-tested through billions of doses were developed by numerous doctors around the world, including by Dr. Peter McCullough in Texas, Dr. Vladimir Zelenko in New York, and [Dr. Shankara Chetty in rural South Africa](#). Much of this unpoliticized and objective truth has been supported through studies, despite heavy mainstream censorship to prop up the flimsy

justification for the Emergency Use Authorization and subsequent charade of [Full FDA-approval](#)—both of which reflects [Regulatory Capture by the pharmaceutical industry](#).

**While it certainly may be up to each individual in seeking the Experimental Injection, there is no sense—let alone being in [direct violation of Informed Consent](#) and Bodily Autonomy—in pressuring people into the procedure via Vaxports when effective treatment methods exist without the risk of serious adverse events.

(3) Since the Experimental Injection stops infection and transmission, forcing the injections on the population is plausible.

*The Experimental Injection NEITHER stops infection NOR stops transmission, rendering any form of mandate like Vaxports useless. There is no sense in checking a person's Injection status when **both the Injected and Non-Injected alike can spread the virus**.

**[Those with Natural Immunity carry 251 TIMES LESS VIRAL LOAD than the Injected](#), which makes ignoring those with Natural Immunity beyond ignorant.

***According to Injection-proponents, the rates of infection would be INVERSELY related to rates of people being Injected. However, [large population studies have shown](#) that there is a [significantly POSITIVE CORRELATION \(+.31\) between a jurisdiction's rates of Experimental Injection and Infection Rates](#). Not coincidentally, [the new cases are increasingly of the Injected](#) because Omicron is evading the already outdated Experimental Injections developed from the original Wuhan strain.

****It has never been acceptable to force people into taking an Experimental Drug, especially when providing Informed Consent has been mostly impossible because they were not properly informed of alternatives to the Experimental Injection, all known major side effects of the Injection, and the fact that neither the corporations nor the government will be held liable for adverse events. Any form of Covid Mandates such as Passports, [fails the Jacobson Test](#). Also, the [pharmaceutical companies together with the FDA are still lacking transparency over their \(dubious\) clinical trials](#), which will not end until 2023!

*****As with the abuse of antibiotics, [pushing mass "vaccination" through Vaxports puts evolutionary pressure for "vaccine"-resistant mutations to occur](#). Most of the major variants have developed from areas of the world where there was mass "vaccination" (including Delta).

*****[There are certain batches or lots of the Experimental Injections that have immensely higher rates of lethality \(1 in 200 being incredibly deadly\)](#), which indicates a real-time human experimentation as well as pre-meditated mass murder.

There are 8 Fundamental Reasons to OPPOSE Vaccine Passports:

1) According to the CDC and Fauci, the **Experimental Injections do NOT STOP TRANSMISSION** and **do NOT PREVENT INFECTION**, much less eradicating HOSPITALIZATION or DEATH. This renders the Injections-as-public good argument completely useless. This doesn't even include the fact that the rate of debilitating side effects and death are alarmingly high already in the short term among the Injected (the clinical trials by the 4 big pharma companies will not end until 2023). The current Experimental Injection was made using the same technology for an attempted vaccine against SARS-1 (which shares 80% of the same genetic material of what we are now facing in SARS-2), and unlike with the current mess, *there were animal studies for SARS-1*. In them, animals injected died shortly after exposure to similar/related viruses due to the body's immune system overreacting to the point of death. Thus, Vaxports have no real scientific basis other than to control people and those who have been so

thoroughly fearmongered that the Vaxports would serve to provide an irrational and baseless “peace of mind.” On the contrary, there is alarming [evidence totally contradicting the purported Vaccine Efficacy](#).

2) There are [countless studies from reputable institutions around the world](#) showing that **[Natural Immunity](#)** (the "Covid Recovered") is **[by far superior to Artificially-induced ones](#)**. In the U.S., the majority of people already have Natural Immunity by having the virus pass through their system—whether or not symptoms were displayed. Natural Immunity can be conferred through prior exposure to SARS-2, or even [cross-immunity from prior exposure to the Common Cold](#) or SARS-1. Natural Immunity, developed in even those who did NOT show symptoms, is superior in every way to the Injection-based one: more robust, longer-lasting, multi-layered, and more specifically targeted to protect areas of the body where the SARS-2 virus resides WITHOUT the harmful side effects of Experimental Injections. Furthermore, studies have shown that those with Natural Immunity have 4.4x HIGHER RISK of suffering SERIOUS SIDE EFFECTS from the Injections. Further still, studies have shown that robust **[Natural Immunity becomes WEAKENED after getting the Experimental Injection](#)**. The above alone offer plenty of reasons why people would exercise their informed decision making NOT to get injected. Thus, **Vaxports would discriminate against Naturally Immune individuals** wanting to keep their [robust/life-long immunity](#) while not wanting to take on an elevated risk of injury/death from being Injected.

3) **Vaxports are discrimination based upon whether or not people took on a risky, experimental Medical Procedure** for a disease that has now (Omicron) become the equivalent of the common cold in terms of its lethality. Considering the low risk of Covid and highly-effective Early Treatment protocols, the corresponding Experimental Injection has needlessly caused an unprecedented number of deaths and serious adverse events reported to the U.S. Department of Health & Human Services' VAERS (Vaccine Adverse Event Reporting System): [despite being underreported by a factor of 30-50 times, over 21,000 Americans deaths have been reported as a result of the Experimental Injections \(though 150,000 is more likely\)](#). There are many people, who based upon their own health circumstances, can NOT get the Experimental Injection: either because of their pre-conditions making the injections a DEADLY proposition (including the aforementioned with Natural Immunity or those with allergies to key components in the Injections), or because their bodies do not produce antibodies through which the injections are designed to work. Places like New York City that implemented Vaxports do NOT ALLOW EXCEPTIONS for these individuals. [Thus, DISCRIMINATION would be the result on the basis of an experimental medical procedure](#).

4) **Vaxports are an unlawful intrusion into privacy and baseless invasion of our bodily autonomy**. People have NEVER been OBLIGATED to disclose personal medical information in order to go about their daily lives, be it entering a restaurant, fitness facility, or government building. Coercing people against their will into the Experimental Injection under the threat of denied opportunities is the very definition of **violating bodily autonomy** ("My Body, The State's Choice"). It is completely **UNETHICAL to be required to disclose personal medical information AND UNETHICAL for businesses to enforce such violations of privacy because of Vaxports**.

5) **It is unnecessary to pressure businesses to be enforcers of Vaxports, which itself will significantly damage businesses even further** in lieu of the [physical, psychological, and financial disaster that were the lockdowns](#). Businesses will suffer further and our county will be in peril!

6) Unfortunately, [2 doses of the Experimental Shot have demonstrated that they lead the Injected to become MORE VULNERABLE to infection than the Non-Injected](#). Not coincidentally, Israel, the leader in this totalitarian means of rule, has made freedom conditional based upon an [Indefinite number of boosters](#) by canceling "Fully-Vaccinated" status of those without the maximum number of boosters. Vaxports will be the gateway to an IRREVERSIBLE RESTRICTION OF FREEDOM based upon an indefinite number of coerced medical procedures. **However, [the WHO](#) and [European Medicines Agency](#) have warned against repeated boosters because of damage to the immune system.**

7) Some people have **religious, spiritual, moral, or ethical objections** to being **injected with materials made from (or tested using) [ABORTED FETUSES](#)**. Thus, Vaxports would discriminate based upon religious beliefs or moral principles. Even having "religious exemptions" would put undue and unnecessary burden on individuals to obtain a religious exemption and the business owners to again be the Vaxport Stasi.

8) **Vaxports would be racist in implementation.** Certain **populations with lower rates of Injection such as with African Americans** (30% fully-injected vs. ~50% fully-injected nationwide as of September 2021) would be **disproportionately discriminated against by Vaxports**. There are many justifiable reasons for their distrust in the government, especially when their community has been the target of horrific medical atrocities, from the the Tuskegee Syphilis Experiment (which was headed by the CDC from 1947-1972 when a whistleblower finally led to pressure to mercifully end the atrocities) to the [CDC injecting 1,500 infants \(mostly poor African and Latin Americans\) in Los Angeles with an experimental measles injection WITHOUT informed consent from 1989-1991](#) (this same violation of health and trust also happening in Haiti and Africa around the same time). This doesn't include poor rural children being injected with an [HPV vaccine that seriously killed or maimed girls in Uganda, India, Peru, and Vietnam as recently as 2009](#).

SUMMARY

In short, stand on the side of true science uncompromised by pharmaceutical industry's blatant financial interests: **OPPOSE** the Vaccine Passport system. Not only is it counterproductive to our physical health and societal stability, Vaxports are nothing but a Totalitarian device designed to control people, harvest their personal medical information, and establish a system of Medical Apartheid discriminating people on the basis of an optional medical procedure that creates second-class citizenship just as segregation did to African Americans in 1960's Jim Crow South, Jews/Gypsies/minorities in 1930's Nazi Germany, and African/Indians in pre-1994 Apartheid South Africa.

Thus, "I'm just doing it because everyone is doing it" or "I'm just following orders" has to stop at a point, or we all contribute to going down the road to totalitarian rule—literally putting the Yellow Star Armbands of Nazi Germany onto people who are without the most up-to-date of

Injections or anything else that the authorities decide to keep adding to the list of decreed drugs. As a business owner, I want nothing to do with being forced to "just follow orders" as the Montgomery County Council's Stasi. Just because DC and other major cities are instituting Vaxports does not mean that it is correct; in fact, supporting Vaxports will turn our beloved Montgomery County into Jim Crow 2.0.

Of all the possible things NOT to politicize, this is certainly it! Whether or not you take donations from the [serially criminal pharmaceutical industry](#), please vote on the side of reason and defend freedom. Please work for the rights of all people with the proper action of opposing Vaccine Passports because otherwise, you will show that Montgomery County's legislative and executive branches have become captured by the pharmaceutical industry.
