- A. Proclamation was presented by Councilmember Friedson recognizing the Winston Churchill High School Boys Lacrosse State Championship.
- B. Commemorated Pride Month, by Council President Glass, County Executive Elrich, Council President Albornoz, and the full Council.

The Council recessed at 9:24 A.M. and reconvened at 10:00 A.M.

GENERAL BUSINESS

A. **Announcements -** Agenda and Calendar Changes

Ms. Rupp, Clerk of the Council, announced a revision to the agenda, noting that item 5C, should be **Expedited Bill 9-22**, Property Tax Credit - Elderly Individuals and Retired Military Services Members -

Amendments; and correcting the title of item 6F to Special Appropriation to the County Government's FY23 Capital Budget and Amendment to the FY23-28 Capital Improvements Program (CIP), Montgomery County Public Schools, Technology Modernization, \$2,077,854.96.

(1) B. Acknowledgement - Receipt of Petitions

There were no petitions received this week.

C. **Action** – Approval of Minutes

There were no minutes for approval this week.

(2) **PRESENTATION -** Youth Safety and Positive Youth Development

Participating in the discussion were Dr. Stoddard, Assistant Chief Administrative Officer; Dr. Crowel, Director, and Ms. Treadvance, Chief, Children, Youth, and Family Services, Department of Health and Human Services (DHHS); Chief Jones, Montgomery County Police Department (MCPD); Mr. McCarthy, State's Attorney; Ms. Riley, Director, Department of Recreation; Mr. Monteleone, Assistant Chief of Teaching, Learning, and Schools, and Mr. Davis, Acting Associate Superintendent, Office of Student and Family Support and Engagement, Montgomery County Public Schools (MCPS); and Ms. Mora, Assistant Chief Administrative Officer.

Received information from the panel on data/statistics concerning incidents and locations of youth violence, short-term and long-term goals and actions for targeted programming and services, efforts by the Street Outreach Network (SON), non-profit organizations and community partners to provide meaningful programs and services, programs offered by MCPS to engage students, and services to provide support and outreach efforts and intervention strategies.

Mr. Albornoz expressed the view that the hours of operation of recreation centers should be extended to help provide safe places for youth to spend time.

Mr. Rice suggested outreach to homeowners associations is needed to help reach residents who may need County services.

Mr. Jawando suggested a meeting with youth sports organizers be held to discuss ways to reach the most at-risk youth.

Mr. Friedson requested Executive Branch staff keep Councilmembers proactively informed of their plans to scale up programs for consideration as part of the

operating budget. He also requested MCPS share plans for Wellness Centers in each school, and a status update on the hiring of school psychologists.

Supported without objection Mr. Friedson's motion to amend the bill by adding an additional ex officio member from DHHS to serve on the Committee.

Enacted draft #2 of **Bill 6-22**, as amended and shown at the end of these minutes.

Senior Legislative Attorney Wellons reviewed the PHED Committee's recommendation, as contained in the staff report.

Mr. Rice suggested that a representative from higher education be appointed in the future to serve on the Board of Directors.

Enacted draft #2 of **Expedited Bill 5-22**, as shown at the end of these minutes.

He noted that the Racial Equity and Social Justice (RESJ) statement recommended an equity assessment and an assessment of the contracting process be completed as part of the CIP process.

RECESS - Maryland Association of Counties (MACo) Annual Visit to Montgomery County

Participating in the discussion were Ms. Price, MACo President, and Mr. Sanderson, Executive Director, Maryland Association of Counties (MACo).

Mr. Rice, MACo Education Subcommittee member, remarked on the importance of the relationship between MACo and Montgomery County.

Received a summary of bills that MACo addressed during the past Maryland Assembly Legislative Session. Mr. Sanderson discussed State legislation including highway user revenue, police oversight efforts, elections management and cost sharing with the State, efforts to pass a bill on elections process which was vetoed by the Governor, and a bill regarding taxable income tax as it impacts local fiscal autonomy.

Mr. Albornoz noted that the Council approved the appointment of members to the Policing Advisory Commission at today's Council meeting and offered Montgomery County's assistance to help guide other jurisdictions in how to stand this up.

Mr. Albornoz requested that MACo assist in creating a State-wide youth leadership program to help develop youth for local leadership roles. He also shared his idea for MACo to create a civic government program to educate residents on the roles and responsibilities of elected officials.

The Council recessed at 1:25 P.M. and reconvened in the Council Hearing Room at 1:35 P.M.

(7) **PUBLIC HEARING - Expedited Bill 20-22**, Office of Food Systems Resilience - Established

The public hearing was conducted. Additional material for the Council's consideration should be submitted by the close of business on July 5, 2022.

(8) **PUBLIC HEARING/ACTION** - Supplemental Appropriation #22-94 to the County Government's FY22 Operating Budget, Technology and Enterprise Business Solutions, Montgomery Connects Computers for You Emergency Connectivity Fund Grants, \$15,975,170 (Source of Funds: Federal Grant)

The public hearing was conducted and the record closed. A Government Operations and Fiscal Policy (GO) Committee worksession is tentatively scheduled for July 14, 2022.

Adopted **Resolution 19-1317**, approving the subject supplemental appropriation. Mr. Rice made the motion which carried without objection. Mr. Hucker and Ms. Navarro were temporarily absent. Mr. Hucker noted later in the meeting that had he been present, he would have voted in the affirmative.

(9) **PUBLIC HEARING/ACTION -** Supplemental Appropriation #22-92 to the County Government's FY22 Operating Budget, Department of Transportation - Taxicab Accessibility Transportation Services Improvement Fund, \$772,329 (Source of Funds: Transportation Services Improvement Fund)

The public hearing was conducted and the record closed.

Supported Mr. Hucker's amendment to reduce the amount of the subject supplemental appropriation by \$30,000, without objection.

Adopted **Resolution 19-1318**, approving the subject supplemental appropriation, as amended. Mr. Hucker made the motion which carried without objection. Ms. Navarro was temporarily absent.

(10) **PUBLIC HEARING/ACTION -** Resolution to extend time until December 30, 2022, for submission of the FY16-22 Montgomery County Fire & Rescue Service (MCFRS) Master Plan

The public hearing was conducted and the record closed.

Adopted **Resolution 19-1319**, approving the extension of time to December 30, 2022, for the submission of the FY16-22 Montgomery County Fire and Rescue Service (MCFRS) Master Plan. Mr. Katz made the motion which carried without objection. Ms. Navarro was temporarily absent.

The County Council for Montgomery County, Maryland approves the following Act

Sec 1. Section 15A-3 is amended as follows:

15A-3. Board of Directors.

- (a) To qualify as the Montgomery County Economic Development Corporation, the Corporation's Board of Directors must have [11] 13 voting members appointed by the County Executive and confirmed by the County Council. [The County Executive should appoint a member of the Workforce Development Board as one of the members of the Corporation's Board of Directors.] The immediate past chair of the Corporation's Board of Directors and the chief executive officer of the County's Workforce Development Organization must be ex-officio, non-voting members of the Corporation's Board of Directors. The Corporation's Board of Directors must [also] include one [officio] non-voting member appointed by the County Executive; and one non-voting member appointed by the Maryland Secretary of Commerce.
- (b) Each voting member serves a 3-year term. The individual terms of the voting members must be staggered. Of the voting members first appointed, four must be appointed for a 1-year term, four must be appointed for a 2-year term, and three must be appointed for a 3-year term. The Executive may extend the term of a voting member first appointed for an additional 6 months or less to coincide with the end of a fiscal year. A voting member appointed to fill a vacancy serves the rest of the unexpired term. A voting member continues in office until his or her successor is appointed and confirmed.

<u>Sec. 2. Expedited Effective Date; Transition.</u> The Council declares that this legislation is necessary for the immediate protection of the public interest. This Act

takes effect on the date on which it becomes law. The 2 voting members added to the Board of Directors of the Montgomery County Economic Development Corporation under Section 1 of this Act must not be appointed before January 1, 2023.

The County Council for Montgomery County, Maryland approves the following Act

Sec. 1. Section 52-110 is amended as follows:

52-110. Property tax credit -- elderly individuals and retired military services members.

(a) *Definitions*. In this Section, the following words have the meanings indicated:

Department means the Department of Finance.

Director means the Director of the Department or the Director's designee.

Dwelling has the same meaning as in § 9-105 of the Tax-Property Article of the Maryland Code.

- (b) *Credit*. As authorized by § 9-258 of the Tax-Property Article of the Maryland Code, an eligible individual may receive a credit against the County property tax imposed on the dwelling of an eligible individual.
- (c) Eligibility. An individual is eligible to receive a property tax credit if:
 - (1) (A) the individual is at least 65 years old;
 - (B) the individual has lived in the same dwelling for at least the preceding 40 years; and
 - (C) the dwelling for which a property tax credit is sought has a maximum assessed value of \$650,000 at the time the individual first applied for the credit;
 - (2) (A) the individual is at least 65 years old;

- (B) the individual is a retired member of the uniformed services of the United States as defined in 10 U.S.C. § 101, the military reserves, or the national guard; and
- (C) the dwelling for which a property tax credit is sought has a maximum assessed value of \$500,000 at the time the individual first applied for the credit; or
- (3) (A) the individual is a surviving spouse of a retired member of the uniformed services of the United States as defined in 10 U.S.C. § 101, the military reserves, or the national guard;
 - (B) the surviving spouse is at least 65 years old; and
 - (C) the surviving spouse has not remarried.
- (d) Amount and duration of credit.
 - (1) The credit allowed under this Section is 20% of the County property tax imposed on the dwelling.
 - (2) The credit must be granted each year for [5] 7 years if the individual remains eligible for the credit.
- (e) Application.
 - (1) A property owner must submit an application to the Director on or before April 1 before the tax year that the individual first seeks to receive the credit. An annual application is not required for an individual to receive the credit.
 - (2) An application must:

- (A) be on the form that the Director requires; and
- (B) demonstrate that the taxpayer is entitled to the credit.
- (f) Regulations. The County Executive may issue regulations under Method 2 to administer this tax credit.

Sec. 2. Expedited Effective Date.

The Council declares that this legislation is necessary for the immediate protection of the public interest. Section 52-110, as amended by Section 1 of this Act, takes effect on July 1, 2022.
