GENERAL BUSINESS

A. **Announcements** - Agenda and Calendar Changes

Ms. Rupp, Clerk of the Council, announced the following agenda changes:

- a. Action has been added today to item #3, Amendment to the County Government's FY23-28 Capital Improvements Program (CIP) and Supplemental Appropriation #23-13 to the FY23 Capital Budget Montgomery County Government Department of Recreation, Cost Sharing: MCG (CIP No. 720601), \$5,000,000 (Source of Funds: Current Revenue General)
- b. The introduction of item #4A, Executive Regulation No. 12-22, Amendment to the Montgomery County Personnel Regulations Extension of the Sunset Date, has been postponed.

- c. Mr. James Hopkins has withdrawn from appointment to the Human Rights Commission, item #4G.

- e. The subject of the proposed closed session this afternoon has changed to the topic of a personnel matter concerning one or more specific appointees, employees, or officials.

(1) B. Acknowledgement - Receipt of Petitions

Recognized a petition received from residents of Montgomery County opposing Thrive Montgomery 2050 Plan.

C. **Action** - Approval of Minutes: There were no minutes for approval.

(2) WRAP-UP WORKSESSION - Thrive 2050

Participating in the discussion were Ms. Dunn, Senior Legislative Analyst; Dr. Orlin, Senior Legislative Analyst; and Ms. Stern, Acting Director, Montgomery County Planning Department.

Ms. Dunn reviewed the comments received from the Department of Housing and Community Affairs (DHCA). Supported the staff recommendations, as contained in the staff report, without objection.

Reviewed feedback from the Office of Agriculture and supported the continued support of agriculture tourism and outdoor recreation in the Agriculture Reserve.

Dr. Orlin discussed the feedback received from the Department of Transportation (MCDOT). Supported without objection, the staff recommendations as contained in the staff report, unless noted below:

Supported without objection, Mr. Friedson's amendment to change the following text in the Equity chapter:

"Improve [upon and achieve greater parity with] travel times and travel costs of transit services [as compared to automotive travel] to achieve greater parity with automotive travel."

Supported without objection, Mr. Rice's amendment to include the following language in the *Build a world-class transit system* section:

"[Increase or otherwise] Support efforts to increase Amtrak and MARC access, services, and utilization, including additional trains, <u>infrastructure</u>, off-peak service, and bidirectional service."

Reviewed the proposed changed to the Environment chapter. Supported without objection the staff recommendations, as contained in the staff report.

Reviewed the proposed changed to the Racial Equity Social Justice (RESJ) chapter, as contained in the staff report. Supported without objection, Mr. Riemer's request that a date citation be added to the data included in this chapter. Mr. Jawando requested that the data includes more specific information.

Supported without objection, Mr. Katz and Mr. Friedson's request to revise the following language:

"As the County plans for the future, it should needs to continue to [pay [special] attention to] support the specific needs of the vulnerable populations impacted by [to be paid to] the hidden costs of poverty and determine more ways to design communities to reduce problems associated with public health, crime, housing instability, food insecurity, and segregation."

Supported without objection, Ms. Navarro's request to include additional language to reflect the connection between the availability of housing of all types throughout the County to equity access to education. Mr. Friedson added that there should also be information included on how to accomplish this.

Supported without objection changing the wording related to County programs and efforts to preserve naturally affordable housing as follows:

"Identifying and [preempting] <u>preventing</u> the potential loss of naturally occurring affordable housing continues to be a priority for the County."

Reviewed the changes made by the Council to the Planning, Housing, and Economic Development (PHED) Committee's draft of the Plan thus far.

Supported without objection maintaining the decision to remove the term "urban" in the phrase "urban heat islands" throughout the Plan.

Supported without objection the following update to the Compact Growth chapter:

"Develop a policy framework to ensure that businesses owned or operated by Black, Indigenous or People of Color are accessing opportunities in new development, or <u>redevelopment</u>."

Mr. Katz requested that Councilmembers receive a clean copy of the final document for review before October 25, when action is scheduled for the Plan.

(6) **Introduction of Bills:**

A. Bill 27-22, Administration - Inspector General - Powers and Duties

Introduced draft #1 of **Bill 27-22**, sponsored by Ms. Navarro, Mr. Friedson, and Mr. Katz. A public hearing is scheduled for November 1, 2022, at 1:30 P.M.

A. Worksession/Action - Zoning Text Amendment (ZTA) 22-07, Residential Multi-Use Low Density, R-30 - Optional Method Development

Ms. Ndou, Legislative Attorney, participated in the discussion.

Mr. Riemer, Chair of the PHED Committee, summarized the background of the ZTA and the Committee's discussions related to this item.

Ms. Ndou reviewed the amendments made by the PHED Committee.
