As you know, since the first bus arrived in April, a considerable number of migrants have chosen to make the DMV, and most specifically Montgomery County, their home.

In that process, many have required shelter/food assistance, and many have been able to enter stable housing and work situation thanks to the collaboration and support of a committed network of volunteers.

This would have been impossible if they had had to rely on our county's services. In the past months I have repeatedly tried to help some of our new neighbors get access to basic county services such as emergency shelter and food aid, without much success.

What I learn is that there are insurmountable barriers for any newcomer to access these services, such as an overabundance of hotlines and a confusing network of providers, out of the way intake centers, requirement to show ID or other residency proofs unavailable for people in informal housing arrangements.

I truly hope the county does not consider this as merely a one-off situation requiring only "emergency" (and as proposed here, insufficient) funding but thinks to provide more long-term support for all newcomers.

I also urge the council to consider providing as much direct assistance as possible (such as housing/childcare vouchers).

We are one of the richest counties in the richest country in the world, we cannot claim lack of resources with a straight face.

Let's be generous and welcoming, let's prove Abbott and Ducey wrong.

Desde la llegada del primer bus en abril, cerca de 1,000 migrantes han elegido asentarse en esta área. Muchos han requerido refugio de emergencia y asistencia alimentaria, y muchos han podido alcanzar una situación estable de vivienda y trabajo gracias a la colaboración y el apoyo de nuestra comprometida red de voluntarios.

Desafortunadamente nada de esto hubiera sido posible si hubieran tenido que depender exclusivamente de los servicios sociales de nuestro condado. Espero que el condado no considere esta situación como una circunstancia excepcional que solo requiere la aprobación de insuficientes fondos de "emergencia", sino que piense en brindar un apoyo sostenido y a largo plazo para todos los nuevos inmigrantes.

También insto al consejo a que considere brindar **asistencia direc**ta a todos los recién llegados (como vales de vivienda/cuidado de niños).

Somos uno de los condados más ricos en el país más rico del mundo, no podemos pretender que no tenemos suficientes recursos.

Seamos generosos y hospitalarios, no le demos la razón a Abbott y Ducey.
