Dear Council President Stewart and Councilmembers:

Hello from your longtime constituents Ann Marie Staudenmaier and Tom Perez. We are writing with requests regarding the FY26 Budget which are crucial for assisting our most vulnerable neighbors, in a time when everyone in Montgomery County is experiencing the repercussions of the current Administration's scorched earth policies. With a 71% increase in homelessness in Montgomery County from 2020-2024, it is crucial that the Council fund programs that are essential to the survival of our client community, especially the ones that provide prevention and exits from homelessness. As someone who has worked as an advocate for people experiencing homelessness for 30 years, these programs are personally extremely important to me.

We ask that the council support the following in the FY2026 Budget:

**Rapid Rehousing provides short term rental assistance** to individuals experiencing homelessness, as well as light case management. This is one of SEPH's primary ways it exits people out of the homelessness system. We must fund \$9,475,427 to cover the costs of sheltering and housing of an estimated 642 current clients and 200 new clients in 2026, so that there is enough to fund everyone's exit out of homelessness.

For our neighbors with chronic health conditions and disabilities, housing is healthcare. Yet, too many are left without the long-term support they need. I urge the council to **fund Permanent Supportive Housing** with \$13,735,903 to support both current clients and new individuals that experience the toughest conditions to exiting homelessness.

No one should be left without a home because they can't afford skyrocketing rents. The council **must fund the Emergency Rental Assistance Program** with \$50 million to ensure all 4,723 households that asked for rental assistance receive an average grant of \$10,581.

In order to prevent homelessness and housing insecurity, we must address the housing shortage. I ask that the Council fully fund **affordable housing development** with \$121.3 million to continue addressing the gap.

If the government cannot adequately address housing struggles, at the very least they must support individuals as they transition to new housing. I support \$2.4 million in **Storage and Moving Assistance** to provide families who were evicted by the Sheriff's Office at least six months of storage to be able to recover and restart.

No one should be forced to risk injury just to enter their own home. Many apartment complexes in Montgomery County remain inaccessible, leaving disabled residents to navigate unsafe conditions daily. We need \$150,000 for the **Montgomery County** 

government to fund retrofitting apartments through nonprofits like Rebuilding Together, ensuring that all residents can live with dignity and safety.

More and more residents across the county are accessing food assistance providers while they struggle to make ends meet. I urge the Council to fund a 10% increase to **food assistance grants** to help providers address rising food costs and increasing need.

We believe in and have always worked towards a Montgomery County where both housing and food is safe, healthy, affordable, and available to everyone. We'd like to thank the Council for your time, consideration, and your leadership.
